2 A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF
 3 RIVERSIDE, CALIFORNIA, MAKING ITS ORDER VACATING
 4 A PUBLIC UTILITY EASEMENT IN PORTIONS OF LOTS 10
 AND 11 ARLINGTON AVENUE TRACT.

5 WHEREAS it appears that the City of Riverside has a
 6 public utility easement over portions of Lots 10 and 11 of
 7 Arlington Avenue Tract; and

8 WHEREAS it appears that said easement is no longer
 9 necessary for present or prospective public use;

10 NOW, THEREFORE, IT IS ORDERED by the City Council of
 11 the City of Riverside, California, that said public utility
 12 easement be and the same is hereby vacated. That said easement
 13 is situated in the City of Riverside, County of Riverside, State
 14 of California, and described as follows:

15 A public utility easement along the southerly
 16 10 feet of Lots 10 and 11 and the westerly 10
 17 feet of Lot 11 of Arlington Avenue Tract, as
 recorded in Book 24, at page 67, Records of
 Riverside County, California.

18 IT IS FURTHER ORDERED that the City Clerk of said City
 19 of Riverside shall cause a certified copy of this resolution
 20 and order, attested by the City Clerk under the seal of said
 21 City, to be recorded in the office of the County Recorder of
 22 Riverside County, California.

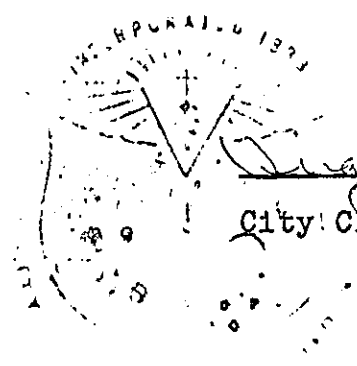

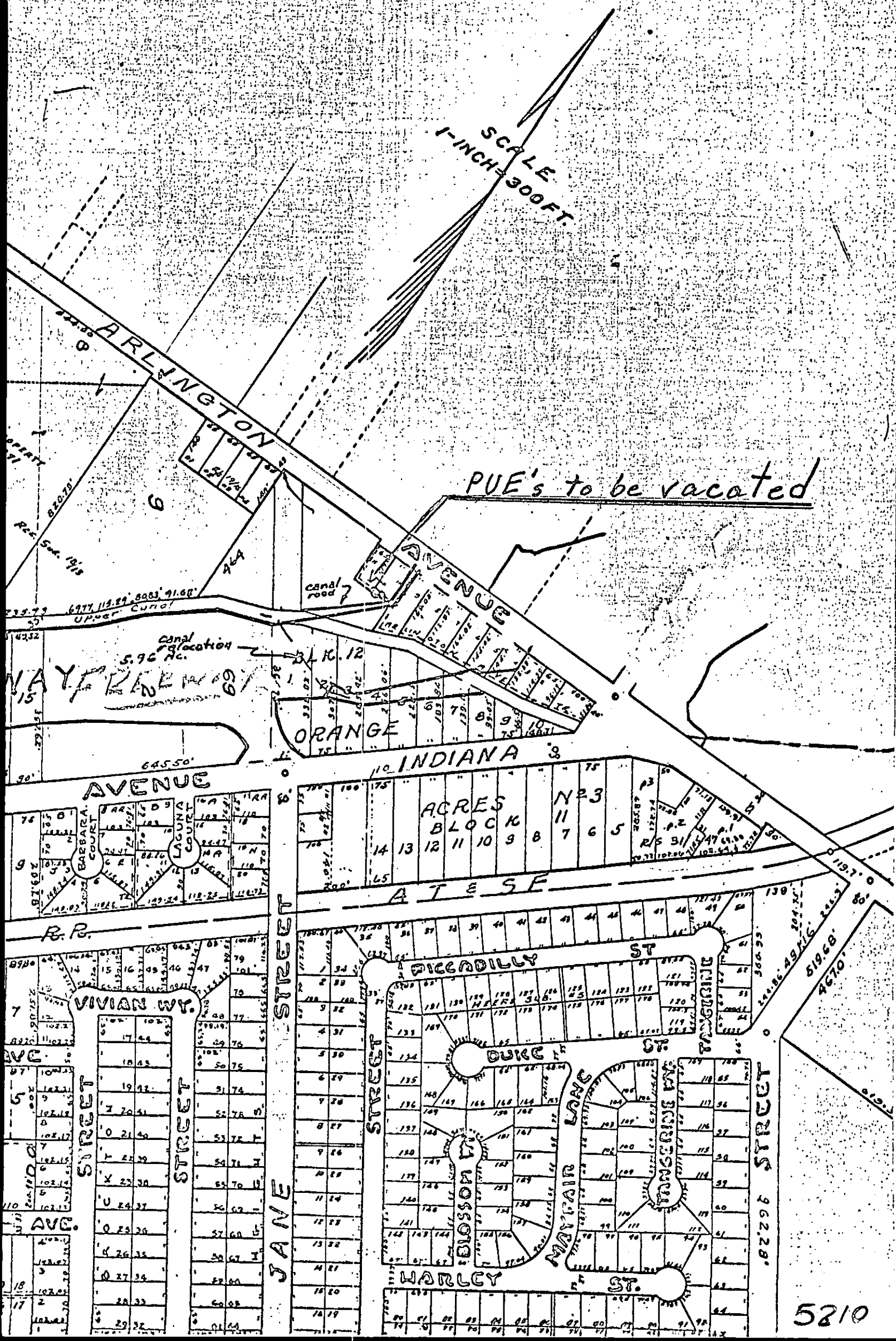
