

RESOLUTION NO. 10152

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIVERSIDE, CALIFORNIA, CHANGING STREET NAMES.

WHEREAS the Planning Commission of the City of Riverside has recommended and the City Council has determined that it is to the best interests of the City that the names of the hereinafter designated streets be changed;

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Riverside that the names of the hereinafter designated streets are changed as follows:

PIERCE DRIVE, described as: *Pk 6*

All that certain street known as Pierce Drive, lying westerly of Pierce Street, northerly of Ravena Avenue and southerly of Raley Drive, said street being shown as Pierce Street on Assessor's Map No.20, on file in Assessor's Map Book 1, pages 24 and 25, Records of Riverside County, California,

be changed to AMES DRIVE.

MARION STREET described as: *Pk 4*

All that portion of that certain street known as Marion Street lying northerly of the northerly line of Central Avenue, as said street is shown on map of Riverview Addition Tract No.4, recorded in Book 7, page 6 of Maps, Records of Riverside County, California, and on map of Mc Claskey Tract recorded in Book 10, pages 36 and 37 of Maps, Records of Riverside County, California,

be changed to WILDERNESS AVENUE.

RINDGE ROAD described as: *Pk 6*

All that portion of that certain street known as Rindge Road, lying northerly of Pierce Street and shown as Lots "~~M-M~~", "~~N-N~~", "O-O" and "P-P" on map of La Sierra Heights Tract No.2, recorded in Book 7, page 66 of Maps, Records of Riverside County, California; Lot "D" on map of Rancho Monte Vista Unit No.1 recorded in Book 27, pages 28 and 29 of Maps, Records of Riverside County, California; Lot "F" on map of Myerscough Subdivision No.1 recorded in Book 41, pages 17 and 18 of Maps, Records of Riverside County, California; and Lot "D" on map of Myerscough Subdivision No.2 recorded in Book 42, pages 37 of Maps, Records of Riverside County, California,

be changed to GOLDEN AVENUE.

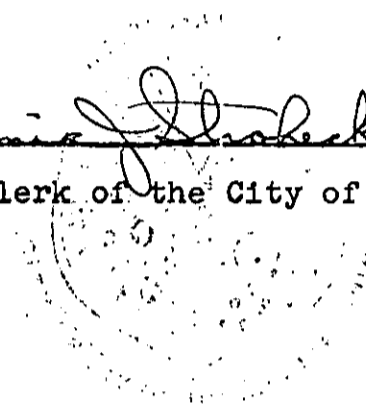

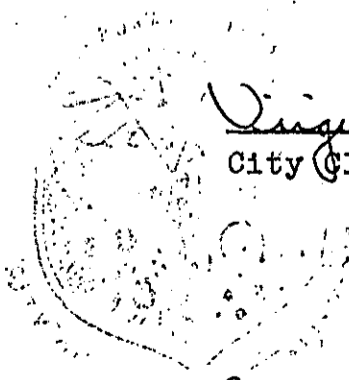
