RESOLUTION NO. 10149

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIVERSIDE, CALIFORNIA, MAKING ITS ORDER VACATING A PORTION OF BROADBENT DRIVE.

WHEREAS on December 1, 1964, the City Council of the City of Riverside adopted Resolution No. 10135 declaring its intention to order the vacation of a portion of Broadbent Drive and fixing the time and place for hearing all persons interested in the proposed vacation pursuant to the provisions of the Street Vacation Act of 1941, being Section 8300 et seq. of Part 3, Division 9 of the Streets and Highways Code of the State of California; and

WHEREAS said proposed vacation was submitted to and acted upon by the Planning Commission of the City of Riverside and notice of hearing said resolution was given as provided by said Street Vacation Act of 1941; and

WHEREAS on the day fixed for the hearing the City Council heard and considered the evidence offered by persons interested and found and hereby finds from all of the evidence submitted that the portion of Broadbent Avenue hereinafter ordered vacated is unnecessary for present and prospective public use.

NOW, THEREFORE, IT IS RESOLVED AND ORDERED by the City Council of the City of Riverside, California, that the portion of Broadbent Drive situate in the City of Riverside, County of Riverside, State of California, and described as follows:

Lots "O" and "P" of University Hills Unit Number 3 as shown by map on file in Book 35, pages 67, 68 and 69 of Maps, Records of Riverside County, California,

is unnecessary for present or prospective public use, and the same be and is hereby vacated.

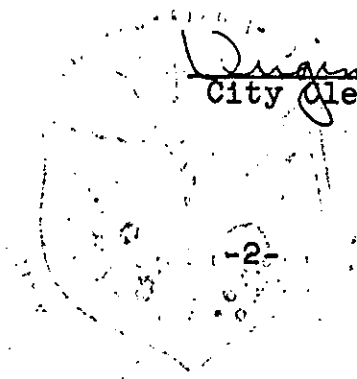

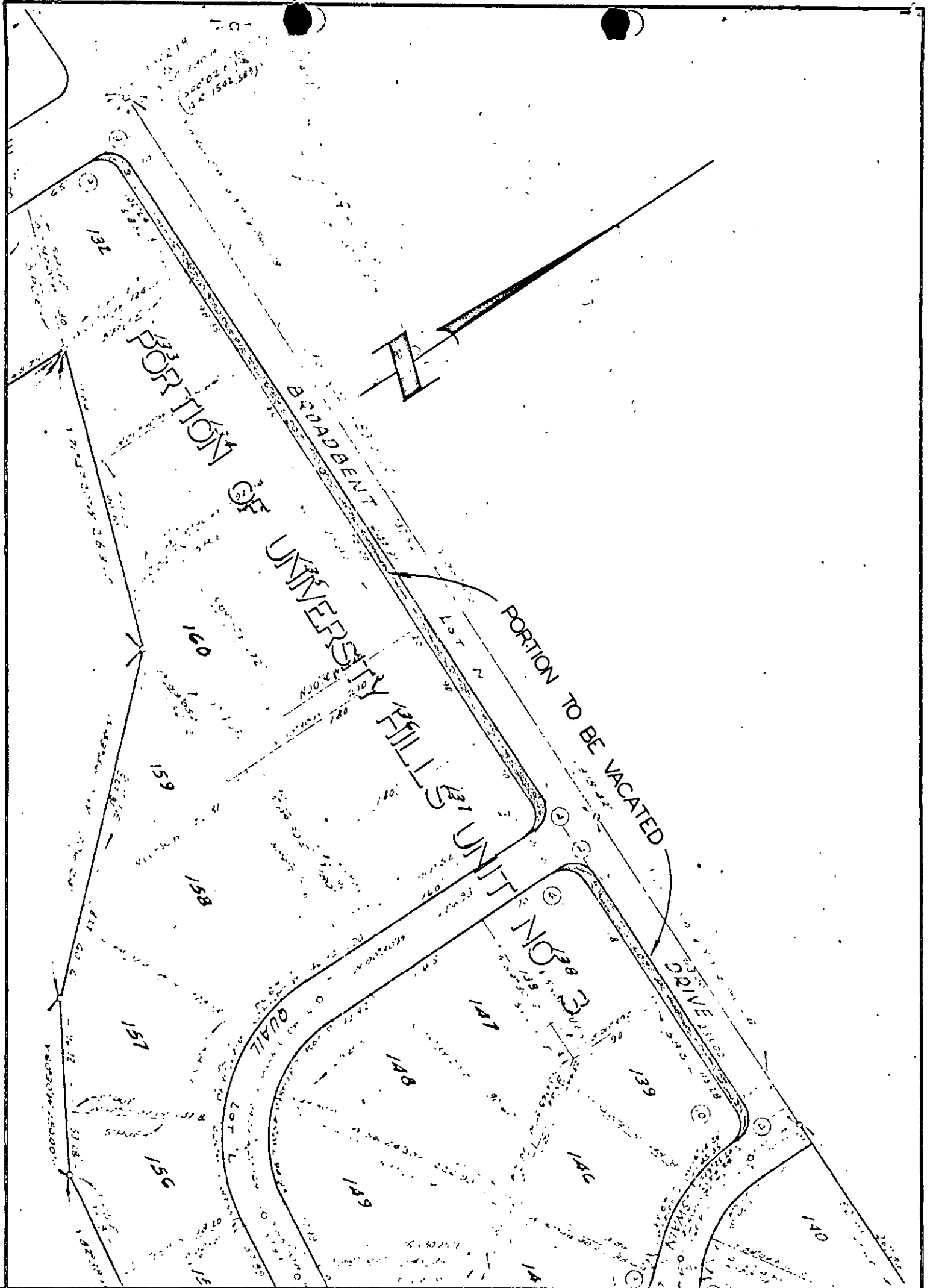
