RESOLUTION NO. 10251

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIVERSIDE, CALIFORNIA, ACKNOWLEDGING THAT CERTAIN PORTIONS OF SANDY LANE ARE AND HAVE BEEN ACCEPTED AS A PUBLIC STREET.

WHEREAS, through long use as a public street there has been an implied dedication by the property owners of the area of Sandy Lane described below; and

WHEREAS, there has been an implied acceptance of this dedication by both the County of Riverside and the City of Riverside through maintenance of this area as a public street for many years; and

WHEREAS, several residents of the City of Riverside have relied on this public street as access to property on which they have built residences; and

WHEREAS, the aforementioned residents have requested the City to continue maintaining this public street;

NOW, THEREFORE, BE IT RESOLVED, ORDERED, FOUND AND DETERMINED by the City Council of the City of Riverside that the following described land has been dedicated and hereby is formally accepted as a public street:

All that portion of "Sandy Lane", shown as "Central Avenue" (Lot "E") on map of Alhambra Addition on file in Book 11, pages 78 and 79 of Maps, Records of Riverside County, California, which lies northerly of the northeasterly prolongation of the southeasterly line of Lot 9 of said Alhambra Addition.

The City Clerk is authorized and directed to cause a certified copy of this resolution to be recorded by the County Recorder of Riverside County.

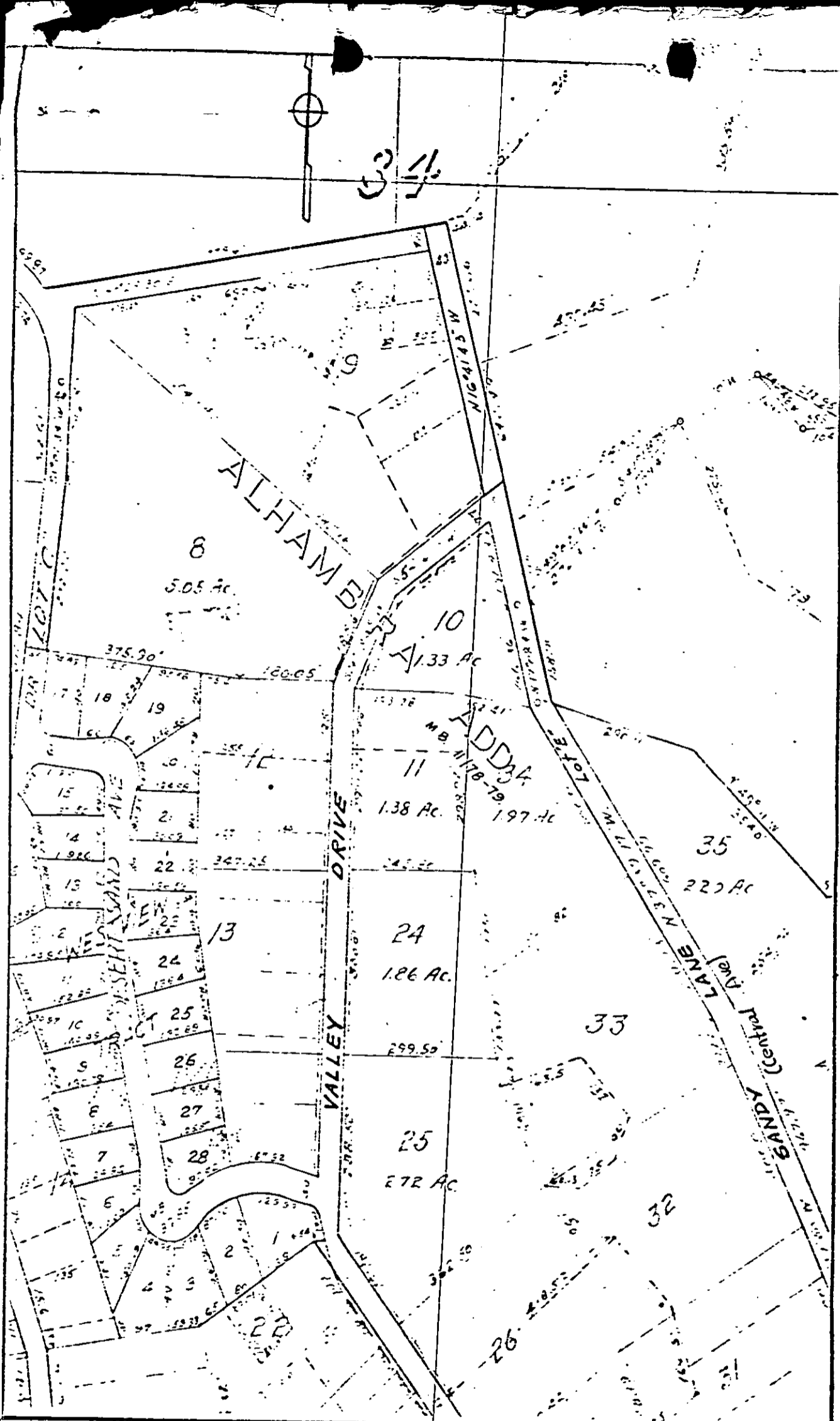
