TO CHANGE NAMES OF COUNTY  
HIGHWAYS

On motion of Supervisor Barnes, seconded  
by Supervisor Varnor, and duly carried, the follow-  
ing resolution was adopted:

WHEREAS, on the 22nd day of September, 1952, this Board  
duly adopted a resolution of intention to change the name of that  
portion of Westwood Drive which was formerly Prospect Avenue as  
shown by map of Campbell's La Sierra Subdivision on file in Book  
13, page 45 of Maps, records of Riverside County, and which was  
changed to Westwood Drive by resolution recorded on September 16,  
1952, in Book 1400, page 361, Official Records of Riverside County,  
back to Prospect Avenue, and to change the name of Prospect Avenue  
as shown by map of Reiche's La Sierra Subdivision on file in Book  
13, page 60 of Maps, records of Riverside County, to Westwood  
Drive; and

WHEREAS, hearing on said resolution was duly set for  
Monday, October 6, 1952, at 10:00 a.m., in the Meeting Room of  
the Board of Supervisors in the Court House at Riverside, California;  
and

WHEREAS, notice of such hearing has been duly given by  
posting notice in at least three (3) public places along the said  
county highways, which posting was completed at least ten (10) days  
before the day set for the hearing, as shown by the affidavit of  
Harold C. McKee on file herein; and

WHEREAS, this Board has considered the matter of the  
change of names of said highways and has heard the evidence concern-  
ing said proposed change of names; now, therefore,

BE IT RESOLVED by the Board of Supervisors of the County  
of Riverside, State of California, in regular session assembled  
this 6th day of October, 1952, that the name of that portion of
