GORDON L. SIMMONS and CRYSTAL J. SIMMONS

Grant to the County of Riverside all that real property in Riverside County, California, described as follows:

That portion of Lot 3 in Block 68 of La Sierra Heights Tract No. 2, on file in Book 7, page 66 of Maps, Records of Riverside County, California, conveyed to Gordon L. Simmons and Crystal J. Simmons by quitclaim deed recorded April 7, 1961, in Book 2883, page 585 of Official Records of said Riverside County, described by metes and bounds as follows:

Beginning at the most southerly corner of the parcel of land conveyed by said deed;

Thence N.17°27'15"W., along the southwesterly line thereof, a distance of 74.09 feet to a point on a 30 foot radius curve, concave southwesterly, from which point a radial line of said curve bears S.18°58'30"W.;

Thence southeasterly along the arc of said 30 foot radius curve, through an angle of 71°47'10", for a distance of 37.59 feet to a point of reverse curve, tangent to a line which bears S.0°45'40"W.;

Thence southerly along the arc of a 115 foot radius curve, concave easterly, through an angle of 5°08', for a distance of 10.30 feet to a point from which a radial line of said curve bears N.85°37'40"E.;

Thence S.19°31'40"E., a distance of 29.57 feet to the southeasterly line of said parcel of land;

Thence S.65°32'W., along said southeasterly line, a distance of 9.03 feet to the Point of Beginning.
