CECIL L. MILLER and ABBIE C. MILLER

Grant to the County of Riverside all that real property in Riverside County, California, described as follows:

That portion of Lot 3 in Block 68 of La Sierra Heights Tract No. 2, on file in Book 7, page 66 of Maps, Records of Riverside County, California, conveyed to Cecil L. Miller and Abbie C. Miller by deed recorded January 13, 1953, in Book 1431, page 265 of Official Records of said Riverside County, described by metes and bounds as follows:

Beginning at the most easterly corner of the parcel of land conveyed by said deed;

Thence S.65°32'W., along the southeasterly line thereof, a distance of 40.58 feet;

Thence N.19°31'40"W., a distance of 48.44 feet to a point on a non-tangent curve having a radius of 115 feet and being concave southwesterly, (a radial line from said point bears S.55°19'W.);

Thence northwesterly along the arc of said curve, through an angle of 5°08', for a distance of 10.30 feet to a point of reverse curve having a radius of 30 feet and being concave southeasterly, (a radial line from said last above mentioned point bears N.50°11'E.);

Thence northwesterly, northerly, northeasterly, and easterly along the arc of said 30 foot radius curve, through an angle of 148°47'30", for a distance of 77.90 feet to the northeasterly line of said parcel of land;

Thence S.17°27'15"E., along said northeasterly line, a distance of 89.47 feet to the Point of Beginning.
