Grantor(s)
as follows

1 On motion of Supervisor Warren, seconded by Supervisor
2 Anderson, and duly carried, the following resolution was adopted:

3 WHEREAS, the real property, hereinafter described, having been acquired
4 for road purposes, is no longer needed by the County for road purposes, said
5 road having been relocated; now, therefore,

6 BE IT RESOLVED by the Board of Supervisors of the County of Riverside,
7 State of California, in regular session assembled this 13th day of November,
8 1956, that the said road right of way is hereby summarily abandoned, the same
9 being described as follows:

10 A triangular parcel of land, being a portion of Blocks 60 and 60-1/2 as
11 shown on Map of East Riverside as filed in Book 7 Page 33 of Maps, records
12 of San Bernardino County, described as follows:

13 Bounded on the northeast by the northwesterly prolongation of the south-
14 westerly line of that certain parcel of land conveyed to Riverside County by
15 deed recorded September 25, 1914, in Deed Book 402 Page 125 thereof, records
16 of Riverside County;

17 Bounded on the south east by the northwesterly line of Iowa Avenue as
18 shown on said Map of East Riverside;

19 Bounded on the west by a line 50' east of and parallel with the following
20 described line: Beginning at the intersection of the center line of Spring
21 Street and Palm Avenue as shown on said Map of East Riverside: Thence S.00°
22 53' E. a distance of 600 feet;

23 Reserving and excepting the easement and right of way therein for
24 existing and future public utility, public service and drainage facilities
25 and structures, pursuant to Section 959.1 of the Streets and Highways Code.
