

RELINQUISHMENT OF STATE HIGHWAY IN THE
CITY OF RIVERSIDE, ROAD VIII-RIV-43-RIV

WHEREAS, a portion of the State highway in the City of Riverside along Magnolia Avenue, Market Street, First Street, Main Street and Russell Street between Arlington Avenue and La Colina Drive, road VIII-Riv-43-Riv, hereinafter particularly described, has been superseded by a change in the location of said highway and

WHEREAS, the California Highway Commission on November 19, 1952, adopted a resolution declaring a certain section of State Highway in the City of Riverside between Magnolia Avenue and Russell Street, road VIII-Riv-43-Riv, to be a freeway; and

WHEREAS, the State of California has acquired rights of way for and has constructed certain relocated city streets, frontage roads and city street connections to the new alignment of road VIII-Riv-43-Riv, between Arlington Avenue and Russell Street, in connection with said freeway; and

WHEREAS, by freeway agreement dated January 11, 1955, and freeway agreement dated February 5, 1957, between the City of Riverside and the State of California, the City has agreed to accept control and maintenance of said city streets and frontage roads upon relinquishment thereof to said City by the State of California; and

WHEREAS, this Commission has found and determined and does hereby find and determine that it is desirable and in the public interest that said portion of State highway so superseded and said city streets and frontage roads be relinquished to the City of Riverside for use as City streets;

NOW, THEREFORE, IT IS VOTED by the California Highway Commission that it relinquish and it does hereby relinquish to the City of Riverside, effective upon the reclamation of a certified copy hereof with the Recorder of Riverside County, that portion of superseded State highway and those portions of said city streets and frontage roads in the City of Riverside together with the right of way and appurtenances thereof, described as follows:

All of the existing State highway right of way, road VIII-Riv-43-Riv, and city streets and frontage roads adjacent to the new alignment of road VIII-Riv-43-Riv shown colored in red on one set of 7 maps consisting of one index map and 6 detail maps filed for record on December 16, 1957, in State Highway Map Book No. 2, Pages 120 to 126, inclusive, Records of Riverside County, which lie between the following termini:

The southerly terminus of superseded State highway, road VIII-Riv-43-Riv, being the prolongation of the Northerly line of Arlington Avenue, between Magnolia Avenue and the Northerly terminus being the center line of said freeway, Engineer's Station 456+15 1/2 of the centerline of improvement.

And the northerly terminus of said portion thereof included within the limits of 30th Street, State Highway road VIII-Riv-19-Riv.

AND EXCEPTING AND RESERVING to the State of California any and all rights of ingress to and egress from the highway hereby relinquished in the adjacent freeway lying southerly of said established highway except at such points as now are or may be established by resolution of this Commission.

The length of superseded State highway hereby relinquished is 4.26 miles.

The southerly terminus of the city streets and frontage roads to be relinquished is 275 1/2 feet right of and opposite Engineer's Station 259+90 1/2 of the centerline of improvement and the Northerly terminus of the city streets and frontage roads hereby relinquished is 403 1/2 feet right of and opposite Engineer's Station 456+47 1/2 of the centerline of improvement.

EXCEPTING AND RESERVING to the State of California any and all rights of ingress to and egress from the city streets and frontage roads hereby relinquished in and to the adjoining freeway except at such points as now are or may be established by resolution of this Commission.

The length of city streets and frontage roads hereby relinquished is 2.88 miles.

The total length of State highway hereby relinquished is 7.10 miles.

The purpose of this resolution is to vest in the City of Riverside all City streets all of the State of California's right, title and interest in and to the portions of State highway hereby relinquished.
