

REVOCATION OF OFFER TO DEDICATE STREETS

WHEREAS the undersigned are the present owners of certain real property situated in the County of Riverside, State of California which constitutes a part of the land described in the Map of La Sierra Gardens, recorded April 8, 1924, as shown by map on file in Book 11, pages 42 to 50, inclusive, of Maps, Riverside County Records, and

WHEREAS the undersigned to the extent of their said property ownership are the successors in interest to the original owner or owners of the land described in said map who offered thereby to dedicate certain lettered street lots for public road purposes, and

WHEREAS by Resolution adopted April 7, 1924 the Board of Supervisors of Riverside County rejected as public streets all avenues and streets shown on said La Sierra Gardens Map, with the exception of Holden Avenue and portions of Pierce and Folk Streets, and

WHEREAS the said property of the undersigned has been used exclusively for farming and other private purposes, and no part thereof has been offered for dedication for public road or other public purposes, except as appeared on said La Sierra Gardens Map.

NOTICE IS HEREBY GIVEN that the undersigned to the extent that they own the following described property do hereby revoke the offers of dedication of all streets, avenues and roads described and shown on the said map of La Sierra Gardens, as shown by map on file in Book 11, pages 42 to 50, inclusive, of Maps, Riverside County Records, which have not heretofore been
