RESOLUTION NO. 10427

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIVERSIDE, CALIFORNIA, MAKING ITS ORDER VACATING A PUBLIC UTILITY EASEMENT WITHIN THE HAYS-FLUKE TRACT.

WHEREAS it appears that the City of Riverside has a public utility easement lying within the Hays-Fluke Tract; and

WHEREAS it appears that said easement is no longer necessary for present or prospective public use;

NOW, THEREFORE, IT IS ORDERED by the City Council of the City of Riverside, California, that said public utility easement be and the same is hereby vacated, said easement being situated in the City of Riverside, County of Riverside, State of California, and described as follows:

That certain public utility easement being the northerly 10 feet of Lots 13, 14, 15, 16, 17 and 18 of Hays-Fluke Tract as shown by map on file in Book 22, page 93 of Maps, Records of Riverside County, California;

The above said 10 foot wide public utility easement to be vacated subject to a right of entry for maintenance and servicing of existing facilities until such time as said facilities are no longer needed.

IT IS FURTHER ORDERED that the City Clerk of said City of Riverside shall cause a certified copy of this resolution and order, attested by the City Clerk under the seal of said City, to be recorded in the office of the County Recorder of Riverside County, California.

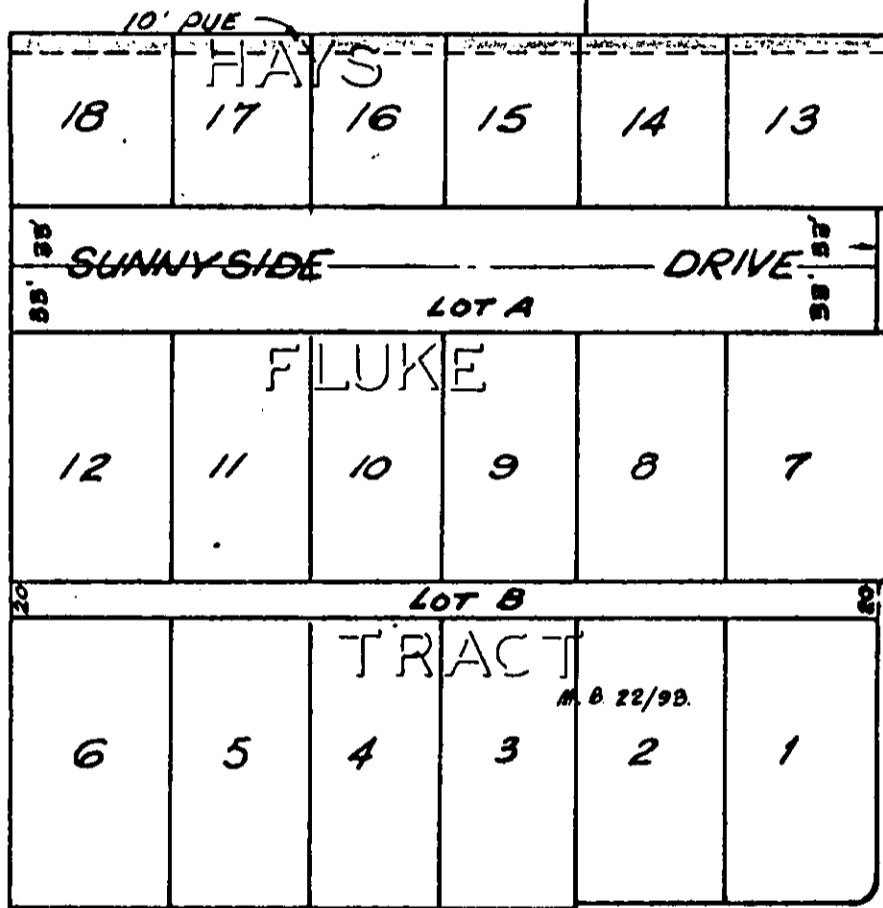
