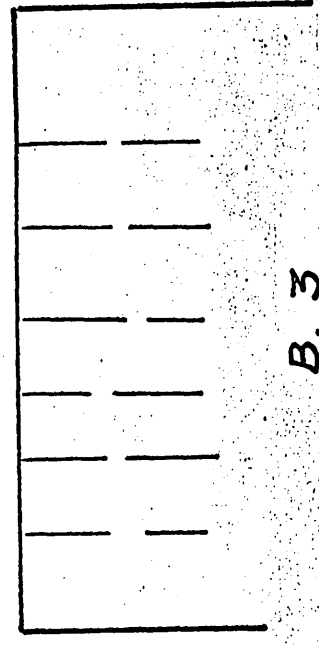
THIRD STREET



ORANGE STREET

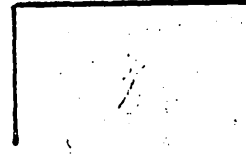
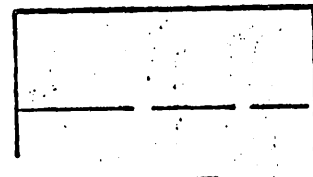
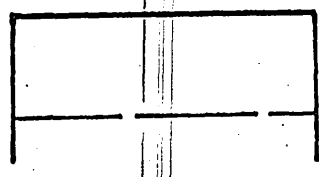
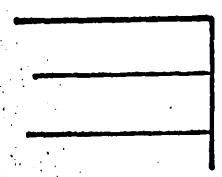


LEMON STREET

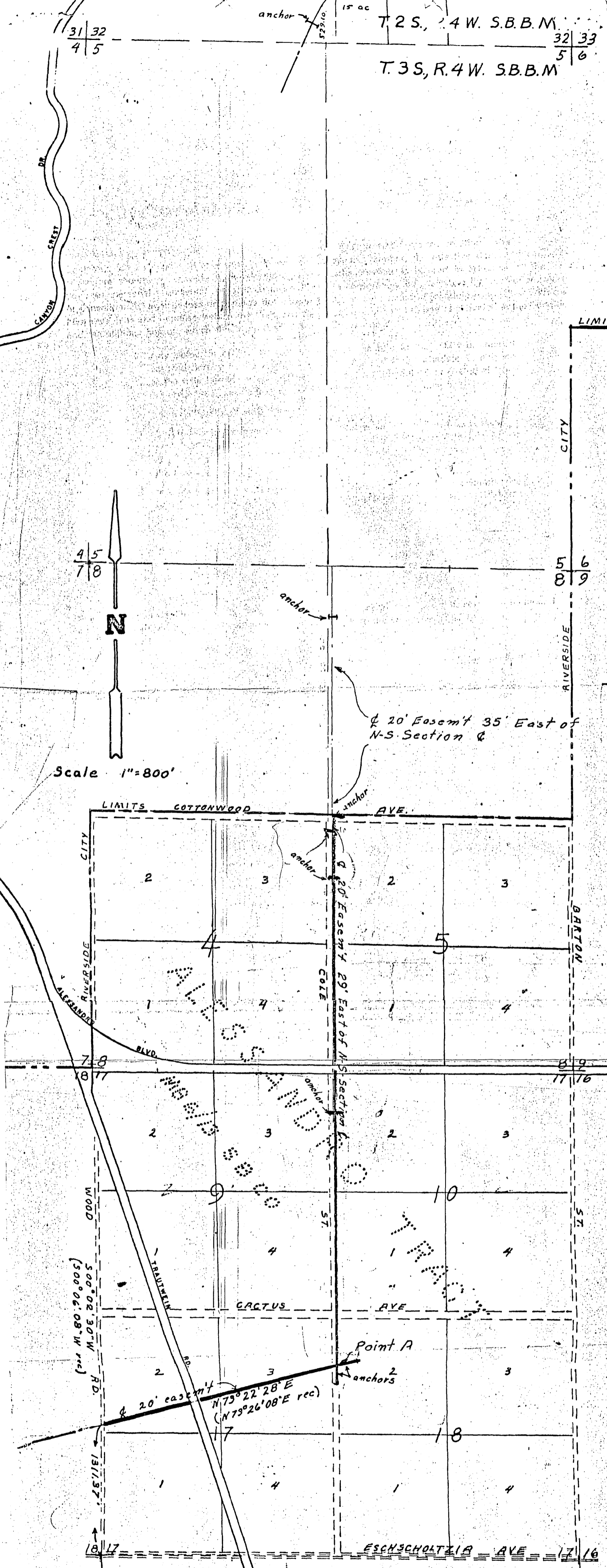
