GRANT OF EASEMENT  
(INDIVIDUAL)

THE GRANTOR... CAROL C. HARGER, a married woman, as her sole and separate property hereby grant... to SOUTHERN CALIFORNIA EDISON COMPANY, a corporation, its successors and assigns, an easement and right of way to construct, use, maintain, alter, add to, repair, replace and/or remove, in, on, and over the real property hereinafter described, situated in the County of Riverside, State of California, an electric line, consisting of poles, necessary guys and anchors, cross-arms, wires and other fixtures and appliances, for conveying electric energy to be used for light, heat, power, telephone and/or other purposes.

Said real property is described as follows:

A strip of land, 10 feet in width, lying within Lot 1, Algodena, as shown on a map recorded in Book 11, pages 80 and 81 of Maps, records of said Riverside County, the centerline of said strip being described as follows:

BEGINNING at a point on the northwesterly line of said Lot 1, distant South 65° 32' West thereon 91.94 feet from the northeasterly corner thereof; thence South 15° 19' 40" East, parallel with the northeasterly line of said lot, a distance of 293.45 feet.
