GRANT OF EASEMENT  
(INDIVIDUAL)

THE GRANTORS JEROME JOHN WILLIAMS and AILEEN M. WILLIAMS, Husband and Wife, hereby grant..... to SOUTHERN CALIFORNIA EDISON COMPANY, a corporation, its successors and assigns, an easement and right of way to construct, use, maintain, alter, add to, repair, replace and/or remove, in, on, and over the real property hereinafter described, situated in the County of Riverside, State of California, an electric line, consisting of poles, necessary guys and anchors, cross-arms, wires and other fixtures and appliances, for conveying electric energy to be used for light, heat, power, telephone and/or other purposes.

Said real property is described as follows:

A strip of land 6 feet in width, lying within Lot 8 of Algodena, as shown on map recorded in Book 11, pages 80 and 81, of Maps, in the office of the Recorder of said Riverside County, the easterly line of said 6 foot strip being described as follows:

BEGINNING at the northeasterly corner of said Lot 8; thence South 14° 13' 28" East, along the easterly line of said Lot 8, a distance of 386.25 feet.
