GRANT OF EASEMENT
(Corporation)

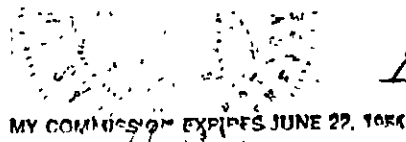
