> Commencing at the intersection of the northwesterly line of Brockton Avenue (80) feet wide with the northeasterly line of Arroyo Drive (vacated), said point being the most southerly

Thence North 61° 04' West along the southwesterly line of said Lot B, 10.57 feet to the point of beginning;

Thence continuing North 61° 04' West along the southwesterly line of said Lot B, 10.72 feet to the beginning of a tangent curve concave northerly having a radius of 15 feet;

Thence easterly and northeasterly along said curve 18.61 feet through a central angle of to the end of said curve, said point being 10 feet

northwesterly as measured at right angles from the southeasterly line of said Lot B;

Thence South 47° 50' West, parallel with the southeasterly line of said Lot B, 10.72 feet to the point of beginning,


