All that certain frontage road lying southwesterly of State Highway 395 and between Pennsylvania Avenue and Fisher Road, as said frontage road was relinquished to the City of Riverside, a map of said relinquishment having been recorded as Instrument No. 142694 on December 21, 1965, in Book 4, page 63 of State Highway Maps, Records of Riverside County, California,

be and the same is hereby named BOX SPRINGS BOULEVARD.

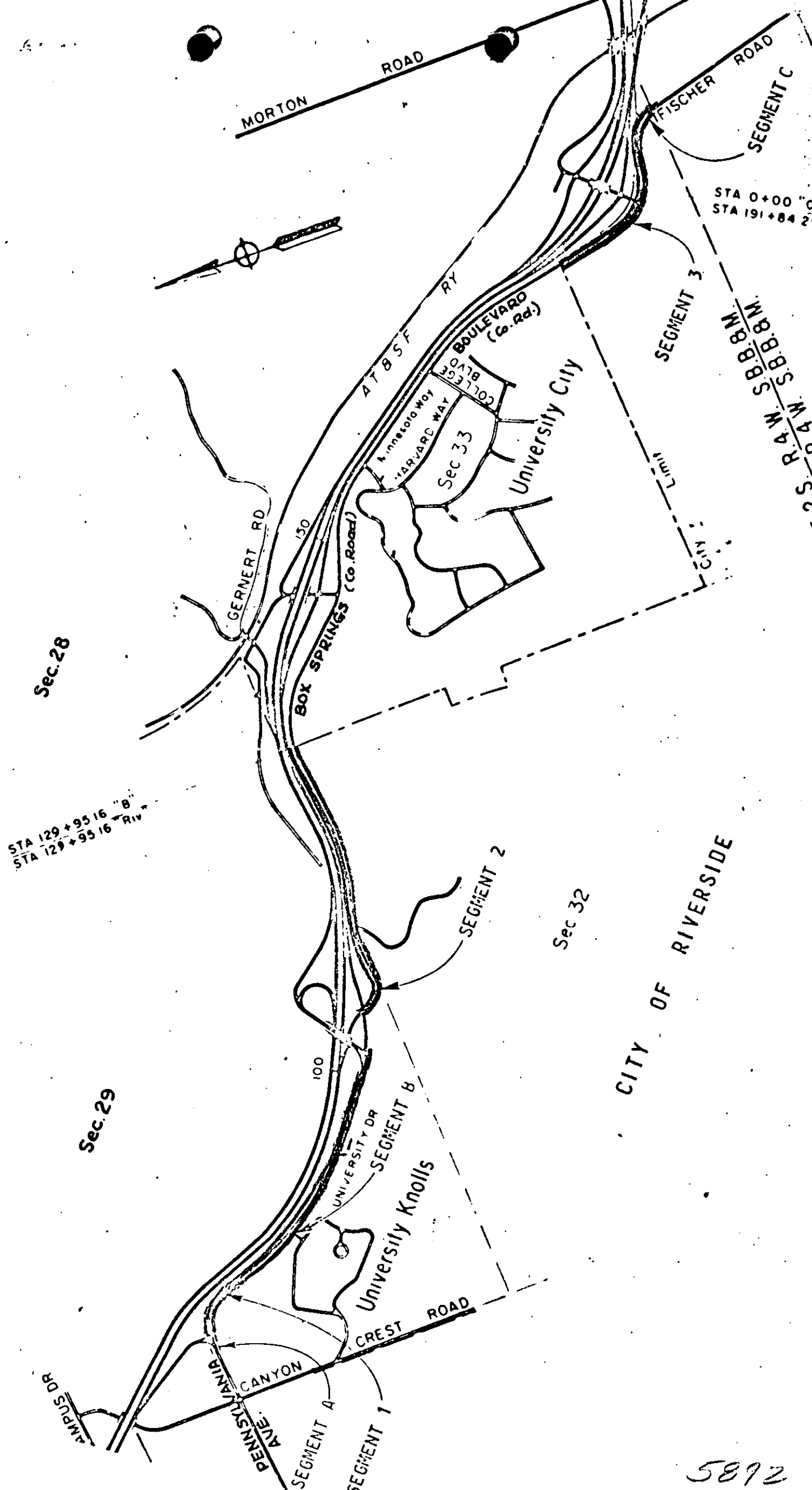
