A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIVERSIDE, CALIFORNIA, CHANGING THE NAME OF A PORTION OF CRESTMORE AVENUE TO MARKET STREET, AND CHANGING THE NAME OF A PORTION OF MARKET STREET TO NORTHBEND STREET.

BE IT RESOLVED by the City Council of the City of Riverside, California, pursuant to the recommendation of the Planning Commission of the City of Riverside that the names of the hereinafter designated portions of streets are changed as follows:

Portion of CRESTMORE AVENUE described as follows:

That portion of Crestmore Avenue, lying northwesterly of the northerly prolongation of the easterly line of Lot 39 of the Overlook Ridge Tract, per map in Book 4, page 94, Records of Riverside County, California, and southeasterly of the northwesterly City Limits boundary line,

be changed to MARKET STREET.

Portion of MARKET STREET described as follows:

That portion of Market Street, lying northeasterly of the northwesterly prolongation of the southwesterly line of Lot 44 of Overlook Ridge Tract as shown by map recorded in Book 4, page 94 of Maps, Records of Riverside County, California, and northeasterly of the southeasterly prolongation of the northeasterly line of Lot 15 of File's Subdivision, as shown by map recorded in Book 5, page 129 of Maps, records of Riverside County, California,

be changed to NORTHBEND STREET.
