2 A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF
3 RIVERSIDE, CALIFORNIA, ACCEPTING THE DEDICATION
4 OF PORTIONS OF CERTAIN STREETS LYING WITHIN
5 TRACT NO. 3 OF THE RIVERVIEW ADDITION TO THE
6 CITY OF RIVERSIDE TO PUBLIC USE FOR STREET
7 PURPOSES TO BE KNOWN AS PORTIONS OF LIBERTY
8 STREET, GRIFFITH STREET AND FREMONT STREET.

9 BE IT RESOLVED by the City Council of the City of
10 Riverside:

11 That the herein described parcels of land lying within
12 Tract No. 3 of the Riverview Addition to the City of Riverside
13 are hereby accepted by the City of Riverside to public use
14 for street purposes to become and be known as portions of
15 LIBERTY STREET, GRIFFITH STREET and FREMONT STREET. Said
16 parcels of land are located in the City of Riverside, County
17 of Riverside, State of California, and are described as follows:

18 Those portions of Griffith Street, Liberty Street
19 and Fremont Street of Tract No. 3 of the River-
20 view Addition to the City of Riverside, as per
21 map recorded in Book 7, page 5 of Maps, Records
22 of Riverside County, California, described as
23 follows:

24 Parcel 1:

25 The easterly one-half of GRIFFITH STREET
26 (50 feet wide) lying northerly of the westerly
27 prolongation of the center line of Liberty Street
28 (40 feet wide) and southerly of the westerly pro-
29 longation of the northerly line of Lot 5, Block
30 14 of said Tract No. 3 of the Riverview Addition.

31 Parcel 2:

32 The northerly one-half of Liberty Street,
lying easterly of the easterly line of said
Griffith Street and westerly of the westerly line
of Fremont Street, as said streets are shown by
said map of Tract No.3 of the Riverview Addition;
including the southerly 13 feet of the north-south
15 foot wide alley in Block 14 of said Tract No.3
of the Riverview Addition.

Parcel 3:

The westerly 15 feet of said Fremont Street
described by bounds as follows:

Bounded on the north by the easterly pro-
longation of the northerly line of Lot 18;

On the east by the easterly line of Lot 1 Rancho



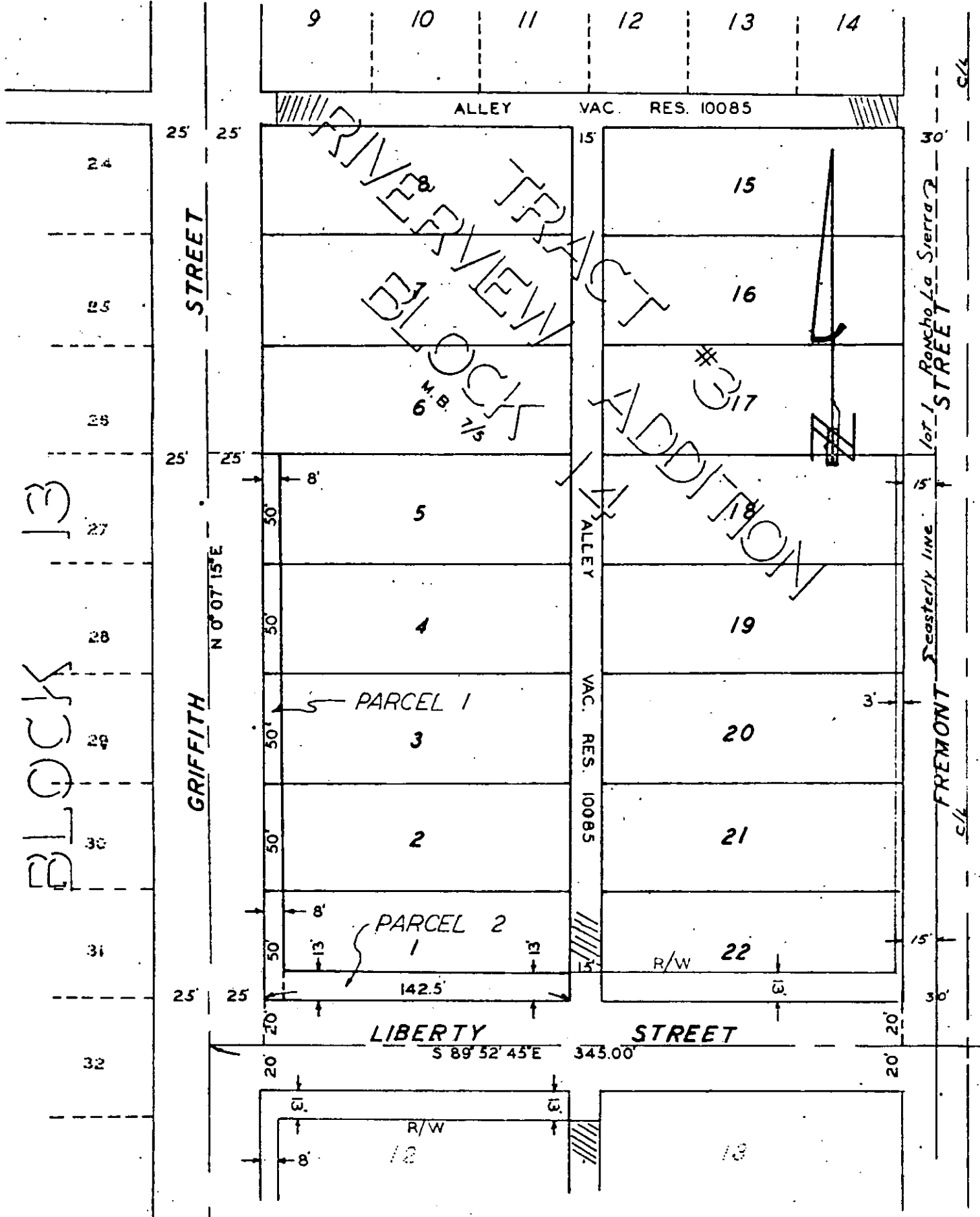
