KNOW ALL MEN BY THESE PRESENTS:

That the STATE OF CALIFORNIA, acting by and through its Director of Public Works, does hereby grant to
the RIVERSIDE WATER COMPANY

all that certain real property situate, lying and being in the City of Riverside,
County of Riverside, State of California, described as follows, to-wit:

Those portions of Block 18 of the Lands of the RIVERSIDE LAND AND IRRIGATING COMPANY as shown by Map on file in Book 1 of Maps, Page 72, Records of San Bernardino County, and Lots 9 and 10 of ARLINGTON AVENUE TRACT as shown by Map on file in Book 24 of Maps, Page 67, Records of said Riverside County, described as a whole as follows:

BEGINNING at a two-inch by two-inch hub marking the Northeast corner of said Lot 10; thence along the Easterly line of said Lot 10 South 0° 04' 26" West 83.69 feet; thence along a tangent curve concave Northwesterly with a radius of 22 feet, through an angle of 43° 53' 06", a distance of 16.85 feet; thence South 43° 57' 32" West 266.10 feet to the Northerly right of way line of the Upper Canal of the Riverside Water Company; thence along said Northerly right of way line North 62° 50' 10" East 7.60 feet; thence North 68° 20' 10" East 32.81 feet; thence leaving said Northerly right of way line and along Course "A" North 43° 57' 32" East 244.34 feet; thence Course "B" North 0° 04' 26" East 99.00 feet to the Northerly line of said Lot 9, said Northerly line being also the Southerly line of Arlington Avenue as it now exists, distant along last said Northerly line South 89° 55' 24" East 16.00 feet from the POINT OF BEGINNING; thence along last said Northerly line North 89° 55' 24" West 16.00 feet to THE POINT OF BEGINNING.

Containing 0.13 of an acre, more or less.

EXCEPTING AND RESERVING unto the State of California any and all rights of ingress to or egress from the land herein conveyed over and across the courses hereinbefore designated as Courses "A" and "B".

It is the purpose of the foregoing exception and reservation to provide that no easement of access shall attach or be appurtenant to the property hereby conveyed, by reason of the fact that the same abuts upon a public way and upon a State highway with access only to the

AND ALSO, those portions of Lots 2, 3, 4, 5, 6, 7 and 8 of ORANGE ACRES NO. 3, as shown by Map on file in Book 16 of Maps, Page 47, Records of said Riverside County, described as a whole as follows:

BEGINNING at the intersection of the Southeasterly line of that certain parcel of land as conveyed to the State of California by Deed recorded April 3, 1953, in Book 1457, Page 583 of Official Records of said Riverside County with the Southerly right of way line of said Upper Canal of the Riverside Water Company; thence along said Southeasterly line South $49^{\circ} 50' 49''$ West 379.84 feet; thence South $82^{\circ} 55' 42''$ West 78.00 feet; thence Course "C" North $4^{\circ} 51' 00''$ East 18.98 feet; thence Course "D" North $49^{\circ} 51' 00''$ East 48.00 feet; thence Course "E" North $79^{\circ} 51' 00''$ East 16.84 feet; thence Course "F" North $53^{\circ} 08' 24''$ East 322.44 feet to said Southerly right of way line; thence along said Southerly right of way line North $82^{\circ} 14' 48''$ East 47.15 feet; thence North $76^{\circ} 40' 10''$ East 8.38 feet to the POINT OF BEGINNING.

Containing 0.36 of an acre, more or less.

EXCEPTING AND RESERVING unto the State of California any and all rights of ingress to or egress from the land herein conveyed over and across the courses hereinbefore designated as Courses "C", "D", "E" and "F".

It is the purpose of the foregoing exception and reservation to provide that no easement of access shall attach or be appurtenant to the property hereby conveyed, by reason of the fact that the same abuts upon a State highway.

Subject to special assessments if a, restrictions, reservations, and easements of record.

AND BE IT FURTHER KNOWN:

FIRST, the Director of Public Works has heretofore found and determined and does hereby find and determine, that the said lands were acquired for State highway purposes and are no longer necessary, and are not now being used for highway uses or purposes;

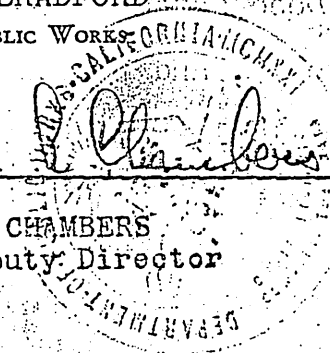
SECOND, that this conveyance is executed pursuant to the authority vested in the Director of Public Works by law and, in particular, by the Streets and Highways Code.

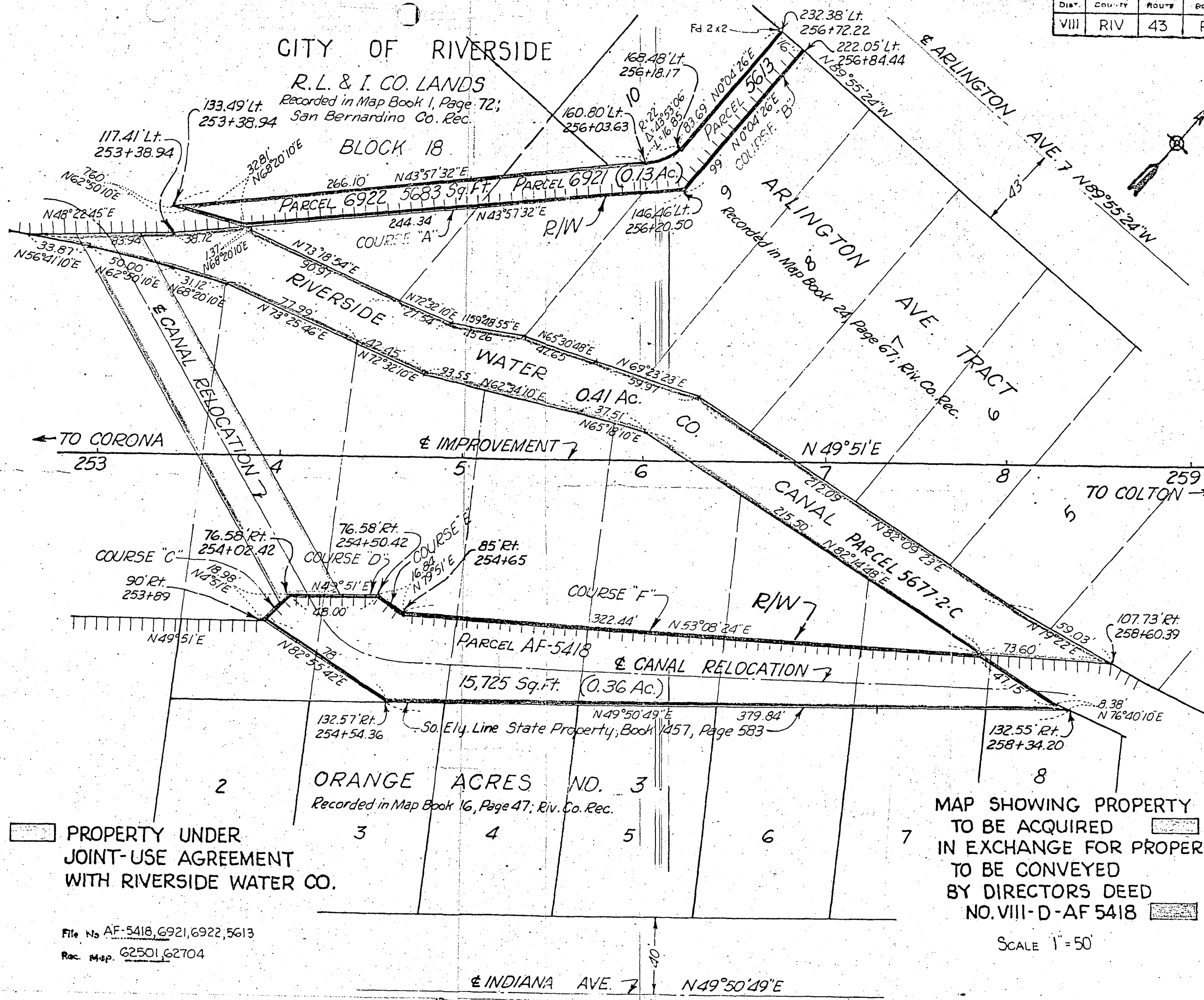
