GRANT DEED

CALIFORNIA FEDERAL SAVINGS AND LOAN ASSOCIATION, a corporation

Grantor

FOR A VALUABLE CONSIDERATION, receipt of which is hereby acknowledged,
does hereby grant to the CITY OF RIVERSIDE, a municipal corporation, the
real property in the City of Riverside, County of Riverside, State of
California, described as follows: --

All that portion of Lot 6 of MARTIN and ORMAND TRACT, as shown by map
on file in Book 6, page 84 of Maps, Records of Riverside County, California,
described as follows:

BEGINNING at a point in the Southeasterly line of that certain parcel of
land conveyed to the City of Riverside, as Parcel 7 by Judgement in Eminent
Domain recorded June 9, 1965, as Instrument No. 66796, Official Records,
Records of Riverside County, California, said point being North 74° 27' 27"
East, 131.13 feet from the most Southerly corner of said Parcel 7;

Thence North 74° 27' 27" East, along said Southeasterly line 81.17 feet;
Thence North 13° 00' 14" East, along the Easterly line of said Parcel 7,
a distance of 67.20 feet to the beginning of a non-tangent curve concave
northerly, having a radius of 1351.00 feet; the initial radial line of said
curve bears South 05° 19' 48" West;

Thence Easterly along said curve, 65.17 feet through a central angle of
02° 45' 50", to a point in the Easterly line of said Lot;

Thence South 17° 55' 33" East, 56.09 feet;
Thence South 00° 15' 27" West, 45.34 feet to the beginning of a non-
tangent curve; the preceding two courses being along the Easterly line of
said Lot;

Thence Westerly on said last curve concave to the North, having a radius
of 1449.00 feet through a central angle of 06° 58' 06", an arc distance of
176.22 feet to the POINT OF BEGINNING; the terminal radial line of said last
curve bears South 08° 41' 09" West. 1226

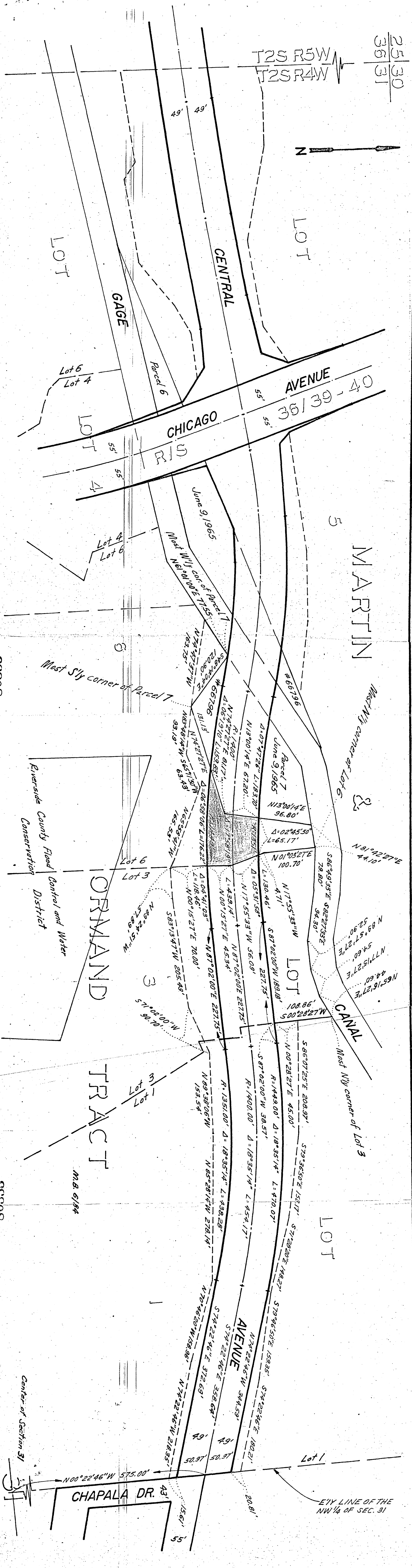
