RESOLUTION NO. 10933

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIVERSIDE, CALIFORNIA, MAKING ITS FINDINGS AND DETERMINATIONS IN THE MATTER OF RESOLUTION OF INTENTION NO. 10911; RESERVING EASEMENTS AND RIGHTS OF WAY AND DETERMINING THAT THE PUBLIC CONVENIENCE AND NECESSITY REQUIRE RESERVATION OF SUCH EASEMENTS AND RIGHTS OF WAY; AND MAKING ITS ORDER VACATING WALKWAYS BETWEEN TWELFTH STREET AND PENNSYLVANIA AVENUE.

WHEREAS on January 9, 1968, the City Council of the City of Riverside adopted Resolution No. 10911 declaring its intention to order the vacation of walkways between Twelfth Street and Pennsylvania Avenue and fixing the time and place of hearing all persons interested in the proposed vacation, pursuant to the provisions of the Street Vacation Act of 1941, being Sections 8300 et seq. of Part 3, Division 9 of the Streets and Highways Code of the State of California; and

WHEREAS said proposed vacation was submitted to and acted upon by the Planning Commission of the City of Riverside and notice of hearing said resolution was given as provided by said Street Vacation Act of 1941; and

WHEREAS on the day fixed for the hearing the City Council heard and considered the evidence offered by persons interested and found and hereby finds from all of the evidence submitted that the walkways ordered vacated are unnecessary for present or prospective public use.

NOW, THEREFORE, IT IS RESOLVED AND ORDERED by the City Council of the City of Riverside, California, that the said walkways in the City of Riverside, County of Riverside, State of California, described as follows:

All of Lots C and D of University Estates No.2 as shown by map on file in Book 24, page 40 of Maps, Records of Riverside County, California; also

All of Lots C and D of University Estates as shown by map on file in Book 25, pages 21 and 22 of Maps, Records of said County;

Also all of Lots D, E and F of University Manor




9 BE IT FURTHER RESOLVED that the City Council does hereby
10 determine that the public convenience and necessity require the
11 reservation of permanent easements and rights of way to construct,
12 maintain, operate, replace, remove and renew sanitary sewers and
13 storm drains and appurtenant structures in, upon, over and across
14 the above described walkways to be vacated, and reserving the
15 right to construct, maintain, operate, replace, remove, renew
16 and enlarge lines of pipe, conduits, cables, poles and other
17 convenient structures, equipment and fixtures for the operation
18 of gas pipe lines, telegraphic and telephone lines, and for
19 the transportation and distribution of electric energy, petroleum
20 and its products, water and incidental purposes, including access
21 and the right to keep the property free from inflammable materials
22 and wood growth and otherwise protect the same from all hazards
23 in, upon and over the above described walkways to be vacated.

24 IT IS FURTHER ORDERED that the City Clerk of said City
25 of Riverside shall cause a certified copy of this order, attested
26 by the City Clerk under the seal of said City to be recorded in
27 the office of the County Recorder of Riverside County, California.
