WHEREAS it appears that the City of Riverside has a public utility easement over a portion of Lot 35, Tract 3488; and


WHEREAS it appears that said easement is no longer necessary for present or prospective public use;


The southwesterly 6 feet of Lot 35, Tract 3488, as recorded in Map Book 58, page 43 of Records of Riverside County.
