RESOLUTION NO. 11030

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIVERSIDE, CALIFORNIA, MAKING ITS ORDER VACATING A PUBLIC UTILITY EASEMENT IN A PORTION OF SECTION 6, TOWNSHIP 3 SOUTH, RANGE 4 WEST, S.B.B.&M.

WHEREAS it appears that the City of Riverside has a public utility easement over a portion of Section 6, Township 3 South, Range 4 West, S.B.B.&M.; and

WHEREAS it appears that said easement is no longer necessary for present or prospective public use;

NOW, THEREFORE, IT IS ORDERED by the City Council of the City of Riverside, California, that said public utility easement be and the same is hereby vacated, said easement being situated in the City of Riverside, County of Riverside, State of California, and described as follows:

The westerly 10 feet of the northerly 1189.39 feet of the northwest quarter of Section 6, Township 3 South, Range 4 West, S.B.B.&M., excepting therefrom the westerly 5 feet of the southerly 25 feet of the herein described property.

IT IS FURTHER ORDERED that the City Clerk of said City of Riverside shall cause a certified copy of this resolution and order, attested by the City Clerk under the seal of said City, to be recorded in the office of the County Recorder of Riverside County, California.
