be and is hereby accepted by the City of Riverside to public use for public utility purposes, including all uses necessary and incidental thereto.

That the herein described property is expressly not accepted for road or street purposes and is not accepted as a part of the City street system.

The City Clerk is authorized and directed to cause a certified copy of this resolution to be recorded by the County Recorder of Riverside County, California.
