ORDINANCE NO. 3558

AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF RIVERSIDE, CALIFORNIA, MAKING ITS ORDER VACATING A PORTION OF COTTONWOOD AVENUE.

WHEREAS on April 9, 1968, the City Council of the City of Riverside adopted Resolution No. 10982 declaring its intention to order the vacation of a portion of Cottonwood Avenue and fixing the time and place of hearing all persons interested in the proposed vacation, pursuant to the provisions of the Street Vacation Act of 1941, being Sections 8300 et seq. of Part 3, Division 9 of the Streets and Highways Code of the State of California; and

WHEREAS on the day fixed for the hearing the City Council heard and considered the evidence offered by persons interested and found, and hereby finds from all of the evidence submitted that the portion of Cottonwood Avenue hereinafter ordered vacated is unnecessary for present or prospective public use;

NOW, THEREFORE, the City Council of the City of Riverside does ordain that said portion of Cottonwood Avenue in the City of Riverside, County of Riverside, State of California, described as follows:

The south 30.00 feet of the Southeast quarter of the Northeast quarter of Section 8, Township 3 South, Range 4 West, San Bernardino Meridian, is unnecessary for present or prospective public use, and the same is hereby vacated.

BE IT FURTHER ORDAINED that the City Clerk shall certify to the adoption of this ordinance and cause it to be published once in the Press. This ordinance shall become effective on the 30th day after the date of its adoption.


