providing for a 10-foot wide easement to the City of Riverside for street purposes.

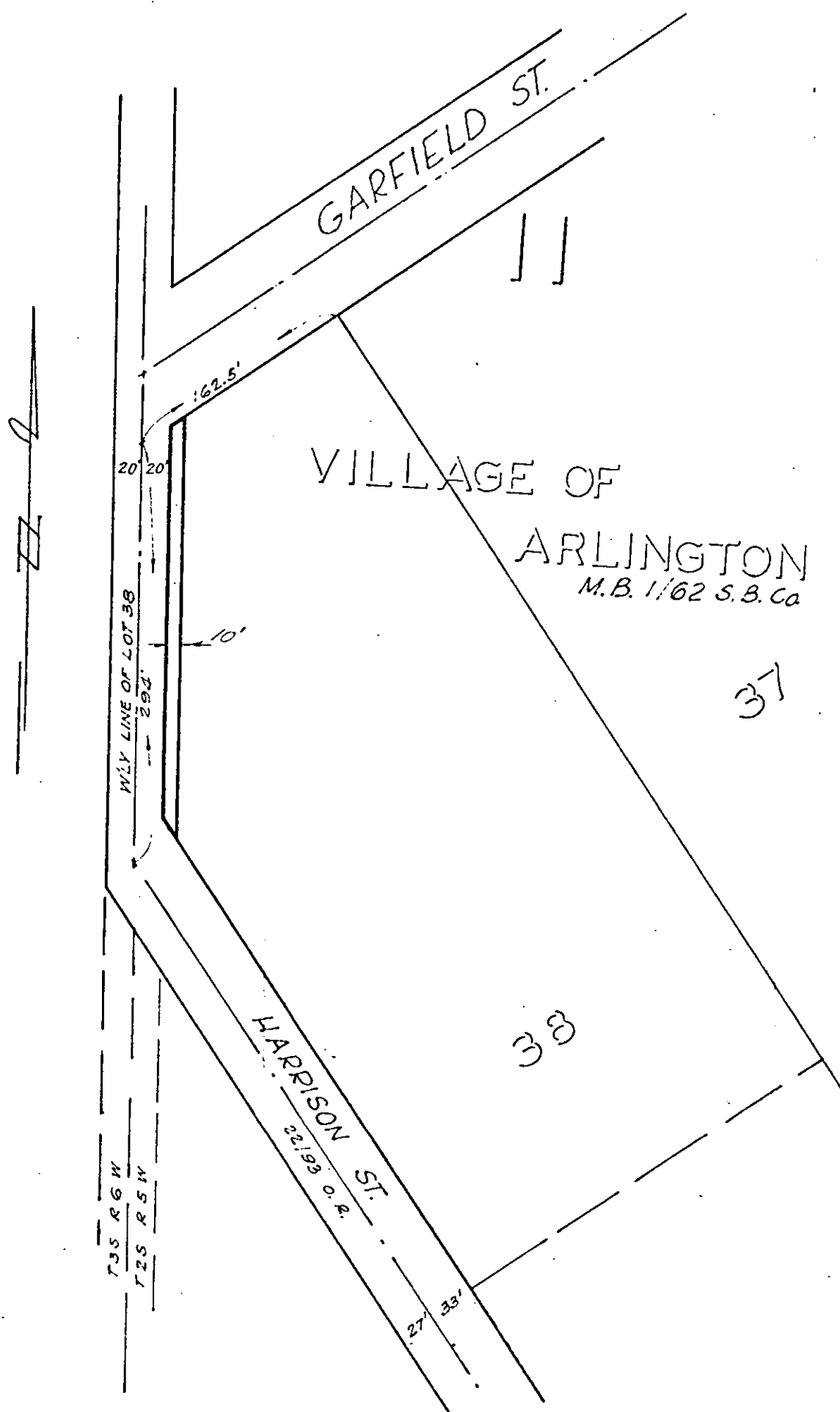
