RESOLUTION NO. 11228

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIVERSIDE, CALIFORNIA, MAKING ITS ORDER VACATING AN ALLEY ADJACENT TO 8133 MAGNOLIA AVENUE.

WHEREAS on February 25, 1969, the City Council of the City of Riverside adopted Resolution No. 11213 declaring its intention to order the vacation of an alley adjacent to 8133 Magnolia Avenue and fixing the time and place of hearing all persons interested in the proposed vacation, pursuant to the provisions of the Street Vacation Act of 1941, being Sections 8300 et seq. of Part 3, Division 9 of the Streets and Highways Code of the State of California; and

WHEREAS on the day fixed for the hearing the City Council heard and considered the evidence offered by persons interested and found, and hereby finds, from all of the evidence submitted that the alley adjacent to 8133 Magnolia Avenue hereinafter ordered vacated is unnecessary for present or prospective public use;

NOW, THEREFORE, IT IS RESOLVED AND ORDERED by the City Council of the City of Riverside, California, that said alley in the City of Riverside, County of Riverside, State of California, described as follows:

That portion of Lot 14 in Block 15 of the Lands of the Riverside Land and Irrigating Company, as shown by map on file in Book 1, page 70 of Maps, records of San Bernardino County, California, described as follows:

Beginning at the most southerly corner of that certain parcel of land conveyed to William J. Wesolek et ux by deed recorded April 12, 1965, Instrument No. 41552 as Parcel 1, Official Records of Riverside County, California;

Thence North 34° 02' 13" West along the south-westerly line of land so conveyed to William J. Wesolek, et ux. a distance of 145 feet;

Thence South 55° 58' 34" West 10.00 feet;

Thence South 34° 02' 13" East 145.00 feet;

Thence North 55° 58' 34" East, 10.00 feet to the point of beginning;

The above parcel of land described by deed to the City of Riverside recorded March 1, 1963, Instrument No. 21142 as Parcel "B" of Official Records, Records of Riverside County, California,


