RESOLUTION NO. 11309

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIVERSIDE, CALIFORNIA, MAKING ITS ORDER VACATING PUBLIC UTILITY EASEMENTS IN TRACT 3081.

WHEREAS it appears that the City of Riverside has public utility easements over portions of Tract 3081; and

WHEREAS it appears that said easements are no longer necessary for present or prospective public use;

NOW, THEREFORE, IT IS ORDERED by the City Council of the City of Riverside, California, that said public utility easements be and the same are hereby vacated, said easements being situated in the City of Riverside, County of Riverside, State of California, and described as follows:

(a) The southwesterly 6 feet of Lot 8 of Tract 3081, on file in Book 54, pages 56, 57, 58 and 59 of Maps, Records of Riverside County, California;

EXCEPTING therefrom the northerly 10.00 feet.

(b) All those 6.00 feet by 6.00 feet public utility easements, as shown by Tract 3081 on file in Book 54, pages 56 through 59 inclusive of Maps, records of Riverside County, California, more particularly described as follows:

The 6.00 feet by 6.00 feet public utility easements lying within Lots 1 and 2; Lots 3 and 4; Lots 5 and 6; Lots 7 and 8; Lots 9 and 10; Lots 11 and 12; Lots 13 and 14; Lots 15 and 16; Lots 17 and 18; Lots 19 and 20; Lots 21 and 22; Lots 23 and 24; Lots 25 and 27; Lots 28 and 29; Lots 30 and 31; Lots 32 and 33; Lots 34 and 35; Lots 36 and 37; Lots 38 and 39; Lots 40 and 41; Lots 42 and 43; Lots 44 and 45; Lots 46 and 47; Lots 50 and 51; Lots 52 and 53; and Lots 54 and 55; Lots 56 and 57; Lots 58 and 59; Lots 60 and 61; Lots 62 and 63; and Lots 64 and 65, as shown on said Tract 3081.

(c) Also 6.00 feet by 6.00 feet public utility easements in Lot 48 and in Lot 49 as shown on said Tract 3081.

IT IS FURTHER ORDERED that the City Clerk of said City of Riverside shall cause a certified copy of this resolution and order, attested by the City Clerk under the seal of said City, to be recorded in the office of the County Recorder of Riverside County, California.
