

RESOLUTION.

On motion of Supervisor McCall, seconded by Supervisor Berkey, and duly carried, the following resolution was adopted:

WHEREAS, the real property hereinafter described was heretofore offered for dedication to public use for road purposes as set forth on the subdivision maps hereinafter referred to, which offer of dedication has not heretofore been accepted by the Board of Supervisors, and

WHEREAS, public convenience and welfare now require the use by the public of said real property for road purposes;

NOW, THEREFORE, BE IT RESOLVED by the Board of Supervisors of the County of Riverside, State of California, in regular session assembled this 23rd day of June, 1958, that the offer of dedication of the real property hereinafter described, as set forth on the subdivision maps hereinafter referred to, is accepted, and said real property is hereby declared open for the uses and purposes of county highways. Said real property is described as follows:

1. ~~LEHIGH LANE~~ - Lot K, designated as Lehigh Lane, shown on Map of University City Unit No. 1, filed in Book 23, Pages 91, 92 and 93, Records of Riverside County.
2. ~~FAIRHAVEN DRIVE~~ - Lot A, designated as Fairhaven Drive, shown on Map of Palm Vista Unit No. 1, filed in Book 28, Pages 45 and 46 of Maps, Records of Riverside County.
3. ~~PJF STREET~~ - Lot B, designated as PJF Street, shown on Map of Cathedral City Highlands No. 3, filed in Book 28, Pages 39 and 40 of Maps, records of Riverside County, California.
4. ~~ZELLAR STREET~~ - That portion of Lot C, designated as Zellar Street, lying southerly of the northeasterly prolongation of the southeasterly line of Lot G, designated as Coleman Avenue, said Lots are shown on Map of Vista Del Lago Tract Unit No. 2, filed in Book 13, Pages 86 to 91, inclusive, of Maps, Records of Riverside County.

5. ARIZONA AVENUE - All that portion of Arizona Avenue lying southeasterly of and contiguous to Blocks 44 and 38 as said Arizona Avenue and Blocks 44 and 38 are shown on Map of Riverside Land and Irrigating Company, filed in Book 1, Page 70 of Maps, Records of San Bernardino County.

BE IT FURTHER RESOLVED that the Clerk of the Board be and he is hereby authorized and directed to cause a certified copy of this resolution to be recorded in the Office of the County Recorder of the County of Riverside, State of California.
