GRANT to COUNTY OF RIVERSIDE the real property in the County of Riverside, State of California, described as follows:

That portion of Lot 8, Aljambra Addition, as shown by map on file in Book 11, Pages 78 and 79 of Maps, Records of the Recorder of Riverside County, California, described by metes and bounds as follows:

Beginning at a point on the southeasterly line of said Lot 8, which bears N.24°58'45" East, 4.78 feet from the southeast corner of said Lot 8;

Thence continuing N.24°58'45" East, along said southeasterly line, 164.33 feet to a point on a 350 foot radius curve, concave to the southeast, from which point a radial line of said 350 foot radius curve bears S.51°26'23" East;

Thence southwesterly along the arc of said 350 foot radius curve concave to the southeast, through an angle of 27°09'18", for an arc distance of 165.88 feet to the point of beginning.
