RESOLUTION

Upon motion of Supervisor Warren seconded by
Supervisor Varner, and duly carried, the following resolution
was adopted, to wit:

WHEREAS, a petition (XXXXXXXXXXXXXXXXXXXXX) to abandon
(the right to accept the dedication of) a portion of a county highway and
way known as Folk Street in the First Road
District, as hereinafter described, was regularly set for hearing
at this time, and

WHEREAS, it appears from the affidavit of C. T. Morsley
on file with the Clerk of this Board, that notice of the time and
place of said hearing was posted conspicuously along the line of the
County highway proposed to be vacated, on August 17, 1954,
and from the affidavit of L. E. Stephenson, on file with
the Clerk of this Board, that notice of the time and place of said
hearing was published on August 19 and 26, 1954 in
the Arlington Times a newspaper of general cir-
culation printed and published in the County of Riverside and desig-
nated by this Board for said publication; and

WHEREAS, this Board has heard all persons and communications
favoring or opposing said proposed abandonment; and

WHEREAS, The Riverside County Planning Commission has made its
written recommendation to this Board, approving of said proposed
abandonment, now, therefore

BE IT RESOLVED, FOUND, AND DETERMINED, by the Board of Super-
visors of the County of Riverside, State of California, in regular
session assembled this 7th day of September, 1954, that
the (portion of the) County highway hereinafter described is unneces-
sary for present or prospective public use, and the same is hereby
abandoned, the same being in the County of Riverside, State of
California, and described as follows:

All that portion of Iola Street, 10 feet in width, as shown on map of Riverside Land and Irrigating Company, as filed in Book 1, page 70 of maps, records of San Bernardino County, California, lying between lots 37 and 38 and lying east of the south-easterly line of Indiana Avenue, as said blocks and avenue are shown on said map of Riverside Land and Irrigating Company.

Also, all that portion of a road situated in lots 5 and 12, lot 37, Riverside road and Indiana Company, as filed in Book 1, page 70 of maps, records of San Bernardino County, California, the center line of which is particularly described as follows:

Start at a point on the center line of Iola Street, distant 715 feet westerly of the intersection of the center line of Indiana Avenue and Iola Street as shown on said map of Riverside Land and Irrigating Company;

Thence easterly a distance of approximately 10 feet;

Thence northeasterly, parallel with the center line of said Iola Street, a distance of a proximately 500 feet to the end.
