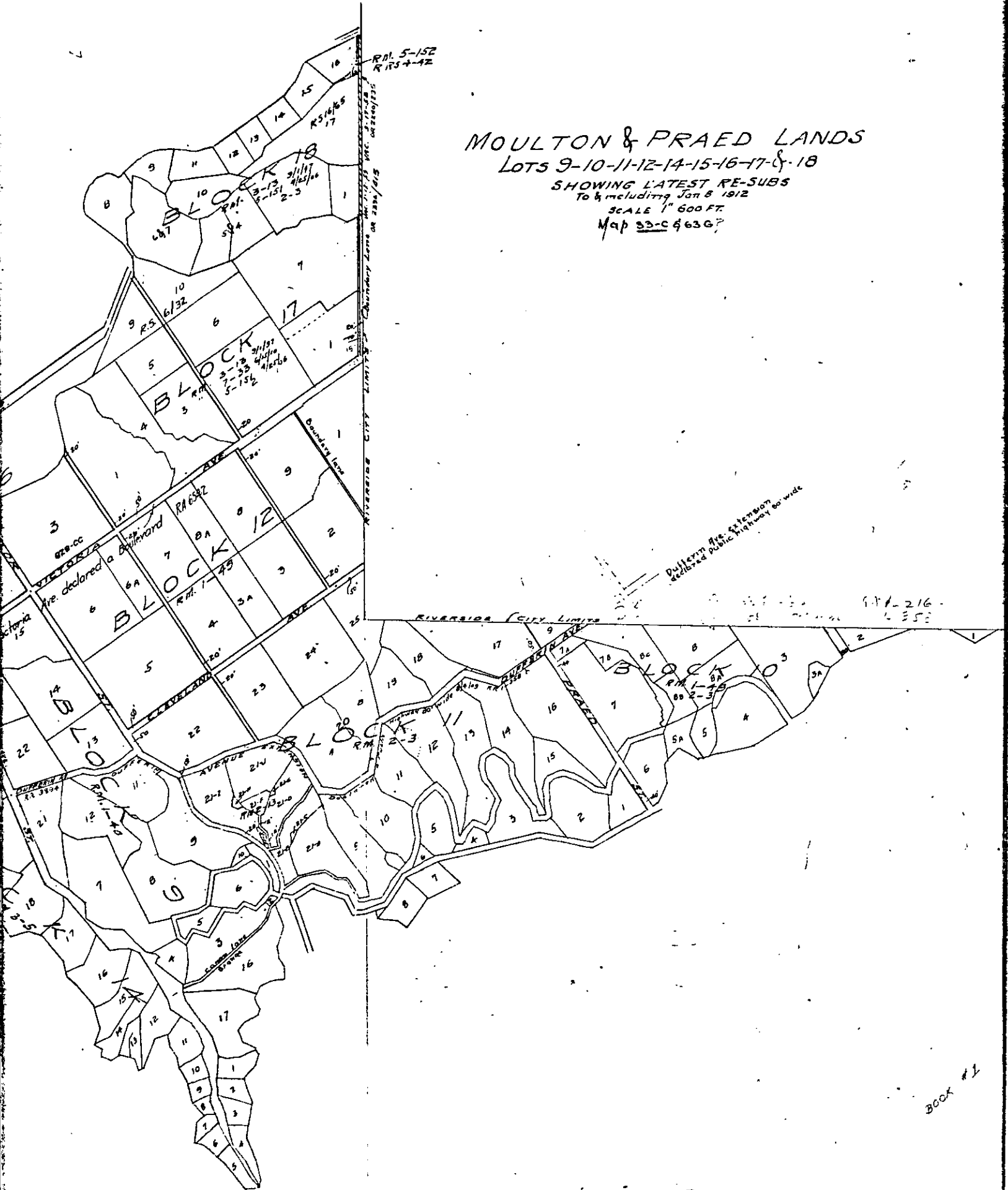
Victoria Ave. Declared a Boulevard from City limits to Filmore Street. . .

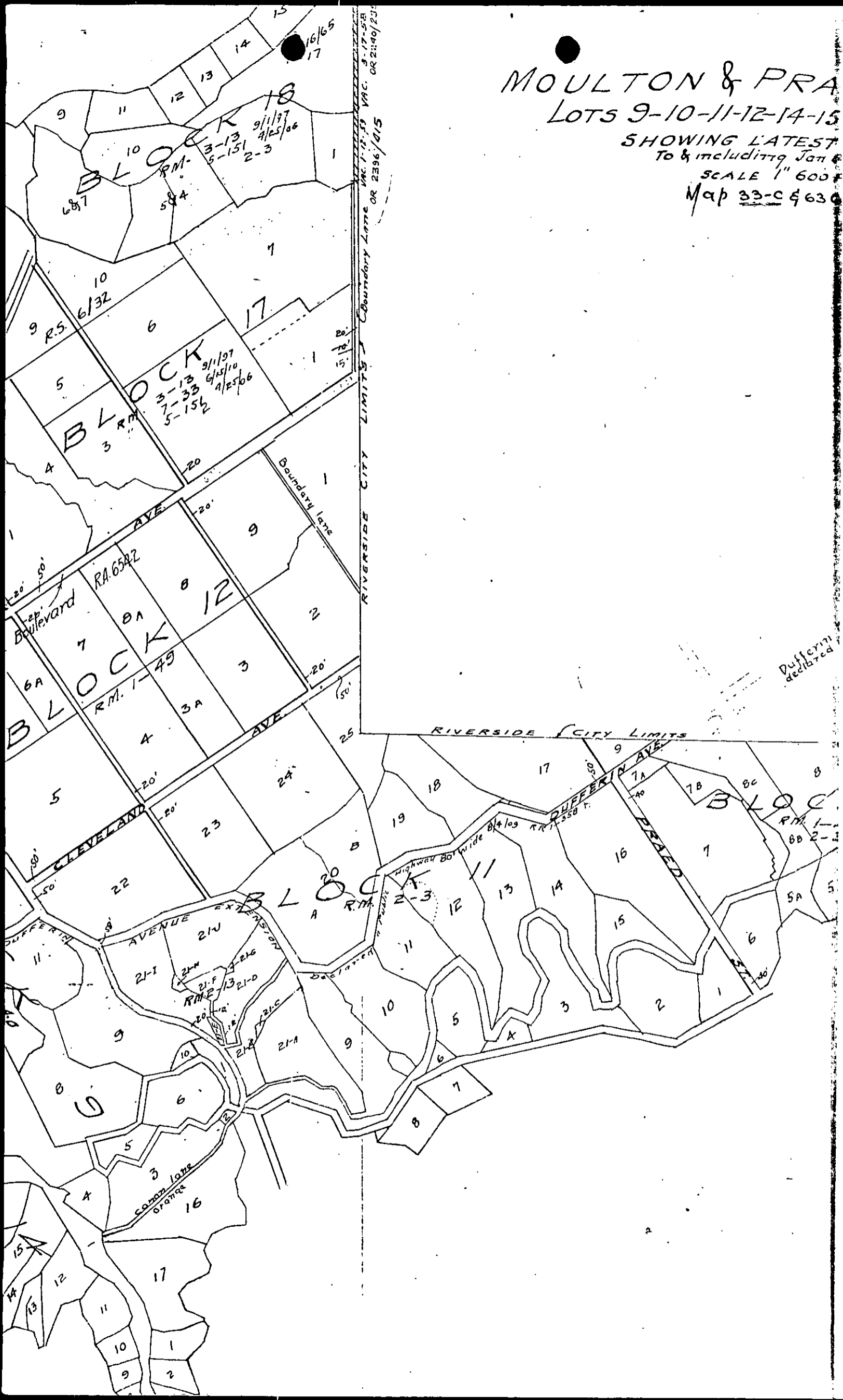
