gation District, a corporation, of the County of Riverside,
State of California, party of the first part, and the

Witnesseth, That for and in consideration of the
sum of One Dollar (\$1.00) in hand paid by the said par-
ty of the second part, the receipt whereof is hereby

acknowledges, the said party of the first part, does by these presents quit claim unto the said party of the second part, for no and purposes, the following described real property, situated in the County of Riverside, State of California, to wit:

The property herein described is a strip of land of the uniform width of one hundred (100) feet, of which the following described line is the center line; beginning at a point on the North boundary line of Section Four (4) in Township Three (3) South Range Four (4) West, S.B. 711, from which the Northeast corner of said Section Four (4) bears South, eighty nine (89) degrees, fifty eight (58) minutes East, Eleven hundred and five (1105) feet; thence South twelve (12) degrees, forty five (45) minutes East, Sixteen hundred and twenty-four (1624) feet to a point; thence deflecting to the left on a ten (10) degree curve, with a central angle of Thirty nine (39) degrees, to a point; thence South, fifty one (51) degrees, forty five (45) minutes East, Three hundred and forty four and $\frac{9}{10}$ (344.9) feet to a point in the North line of the South half $\frac{1}{2}$ of the Southeast Quarter ($\frac{1}{4}$) of the North east Quarter ($\frac{1}{4}$) of said Section Four (4); said last mentioned point being Station seventy three (73) plus Thirty-two and $\frac{1}{10}$ (32.1) of the Cor & Springs Canon Road Survey as surveyed in November, 1893, a map of which is placed on file with the clerk of the Board of Supervisors of Riverside County.
