RESOLUTION.

On motion of Supervisor Jones, seconded by Supervisor Chamberlain, and duly carried, the following resolution was adopted:

WHEREAS, the real property hereinafter described was heretofore offered for dedication to public use for road purposes as set forth on the subdivision map hereinafter referred to, which offer of dedication has not heretofore been accepted by the Board of Supervisors, and

WHEREAS, public convenience and welfare now require the use by the public of said real property for road purposes; now, therefore,

BE IT RESOLVED by the Board of Supervisors of the County of Riverside, State of California, in regular session assembled this 13th day of May, 1957, that the offer of dedication of the real property hereinafter described, as set forth on the subdivision map hereinafter referred to, is accepted, and said real property is hereby declared open for the uses and purposes of county highway

Said real property is described as follows:

Lot A, designated as 54th Street, as shown on Map of Jurupa Hills Subdivision Unit No. 1, as filed in Book 30, Page 47 of Maps, records of Riverside County, California.

- Lot A, designated as Casa Loma Road;
- Lot B, " " Maui Road;
- Lot C, " " Miracle Hill Road;
- Lot D, " " Eliseo Road;
- Lot E, " " Agua Cayendo Road;
- Lot F, " " Cuando Way, as shown on Map of Desert Hot Springs

Annex Unit No. 1, as filed in Book 27, Pages 22, 23 and 24 of Maps, records of Riverside County, California.

Lot A, designated as K Street and now known as Beach Street, as shown on Map of Sparmland Unit No. 5, as filed in Book 15, Page 54 of Maps, records of Riverside County, California.

Lot B, designated as Via Del Rio, as shown on Map of Yorba Heights Unit No. 1, as filed in Book 22, Page 5 of Maps, records of Riverside County, California.

All that portion of 5th Street, 50 feet in width, lying between the southerly line of Reservoir Avenue and the southerly line of Pico Road as conveyed to Riverside County by Deed recorded December 12, 1950, in Book 1227, Page 109 thereof, records of Riverside County, California, said 5th Street and Reservoir Avenue are shown on Amended Map No. 1 of Lake View, as filed in Book 2, Page 24 of Maps, records of Riverside County, California.

All that portion of Lot K, now known as Collett Avenue, lying southerly and contiguous to Block 52, as shown on Map of Tract No. 2 of La Sierra Heights, as filed in Book 7, Page 66 of Maps, records of Riverside County, California.

BE IT FURTHER RESOLVED that the Clerk of the Board be and he is hereby authorized and directed to cause a certified copy of this Resolution to be recorded in the office of the County Recorder of the County of Riverside, State of California.
