E A S E M E N T

FOR VALUABLE CONSIDERATION, receipt of which is hereby acknowledged, \_\_\_\_\_

MACK THOMPSON and HELEN THOMPSON, husband and wife,

as Grantors, grant(s) to the CITY OF RIVERSIDE, a municipal corporation of the State of California, as Grantee, its successors and assigns, a perpetual easement and right-of-way for the construction, reconstruction, maintenance, operation, inspection, repair, replacement, relocation, renewal and removal of \_\_\_\_\_  
public sewer facilities

together with all necessary appurtenances, in, under, upon, over and along that certain real property situated in the County of Riverside, State of California, described as follows:

Those portions of Lots 118 and 119 of Victoria Park Addition to the City of Riverside, California, as shown by map on file in Book 7 of Maps at page 18 thereof, Records of Riverside County, California, lying within a strip of land 10.00 feet in width, the centerline of said strip of land being described as follows:

- Commencing at the northeasterly corner of said Lot 118;
  - Thence North 78° 09' 00" West along the northerly line of said Lot 118, a distance of 8.00 feet to a point therein for the TRUE POINT OF BEGINNING;
  - Thence South 09° 45' 49" West, a distance of 86.09 feet to the beginning of a tangent curve, concave to the east, having a radius of 200.00 feet;
  - Thence southerly along said curve, to the left, through a central angle of 07° 08' 11", an arc distance of 24.91 feet to the end thereof;
  - Thence South 02° 37' 38" West, a distance of 335.86 feet to a point in a line, parallel with and distant southerly 5.00 feet, measured at right angles, from the northerly line of Lot 127 of said Victoria Park Addition.
- The sidelines of said strip of land shall be lengthened or shortened so as to terminate in the northerly line of said Lot 118.

Provided, however, that the Grantor reserves the right to use and enjoy the land over which said easement and right-of-way is granted, for any purpose and in any manner which does not interfere with or impair the right of the Grantee to use said easement and right-of-way.

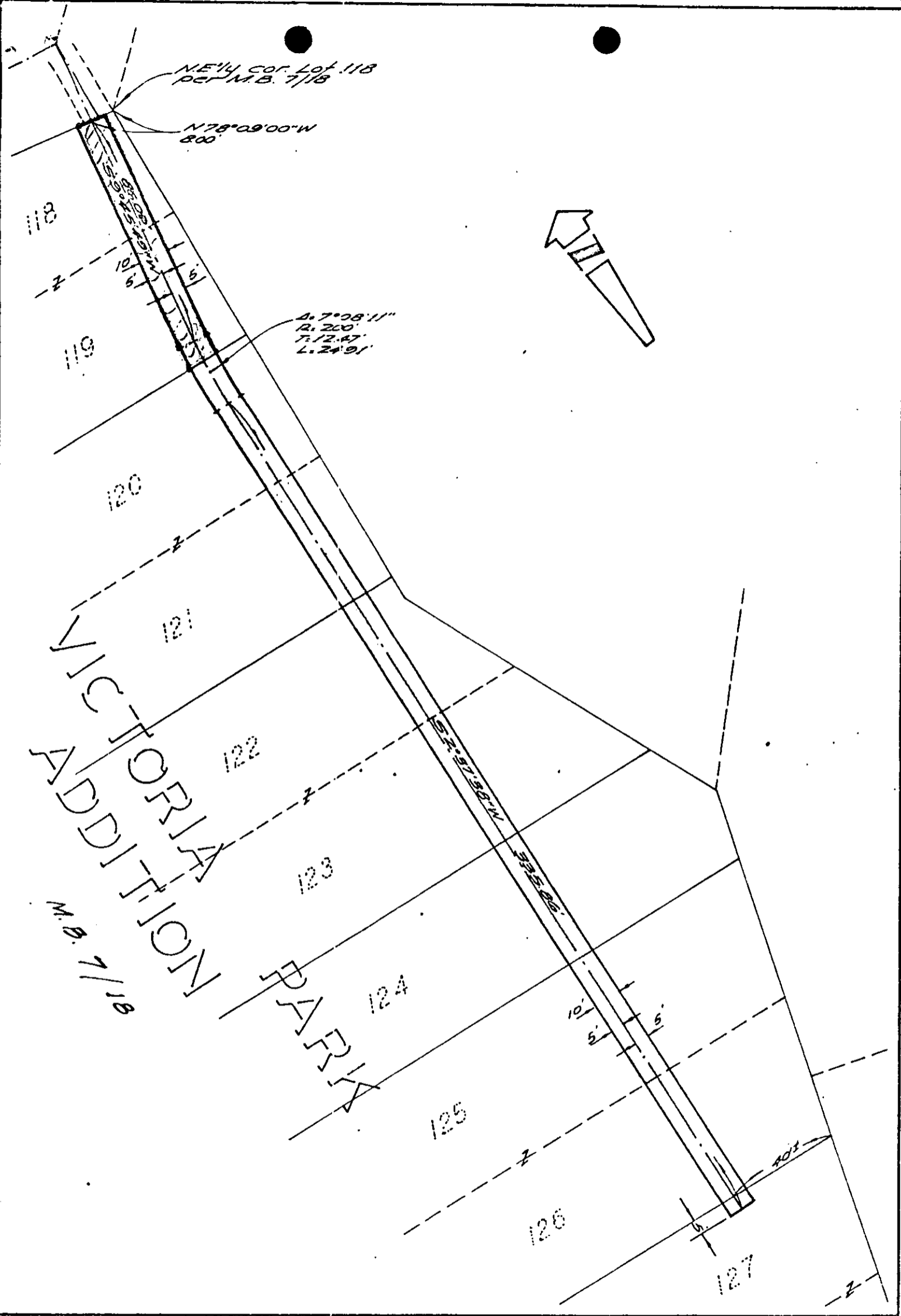
