RESOLUTION NO. 11695

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIVERSIDE, CALIFORNIA, MAKING ITS FINDINGS AND DETERMINATIONS IN THE MATTER OF RESOLUTION OF INTENTION NO. 11673; RESERVING FLOOD CONTROL, DRAINAGE AND SEWER EASEMENTS AND DETERMINING THAT THE PUBLIC CONVENIENCE AND NECESSITY REQUIRE RESERVATION OF SUCH EASEMENTS; AND MAKING ITS ORDER VACATING PORTIONS OF LA SIERRA AVENUE.

WHEREAS on May 4, 1971, the City Council of the City of Riverside adopted Resolution No. 11673 declaring its intention to order the vacation of portions of La Sierra Avenue and fixing the time and place of hearing all persons interested in the proposed vacation, pursuant to the provisions of the Street Vacation Act of 1941, being Sections 8300 et seq. of Part 3, Division 9 of the Streets and Highways Code of the State of California; and

WHEREAS said proposed vacation was submitted to and acted upon by the Planning Commission of the City of Riverside and notice of hearing said resolution was given as provided by said Street Vacation Act of 1941; and

WHEREAS on the day fixed for the hearing the City Council heard and considered the evidence offered by persons interested and found and hereby finds from all of the evidence submitted that the portions of said street ordered vacated is unnecessary for present or prospective public use.

NOW, THEREFORE, IT IS RESOLVED AND ORDERED by the City Council of the City of Riverside, California, that the said portions of said street in the City of Riverside, County of Riverside, State of California, described as follows:

PARCEL 1

Beginning at the most southerly corner of Block 37 of said La Sierra Gardens;

Thence South 32° 23' 10" East along a line connecting said most southerly corner of Block 37 with the most westerly corner of Block 40 of said La Sierra Gardens, a distance of 2.06 feet to a point therein;

Thence North 77° 00' 26" West, a distance of 9.94 feet to a point in a curve, concave to the northeast, having a radius of 2,645.00 feet, from which the center of said curve bears North 56° 59' 15" East;

Thence northwesterly along said curve, to the right, through a central angle of 05° 49' 16", an arc distance of 268.73 feet to a point of reverse curvature with a curve, concave to the southwest, having a radius of 2,755.00 feet, the radial line at said point bears North 62° 48' 31" East;

Thence North 56° 01' 39" East along said south-westerly prolongation, a distance of 5.00 feet to the most westerly corner of the parcel so conveyed, said point being in the southwesterly line of said Block 40;

Thence North 33° 58' 21" West along said south-westerly line, a distance of 714.64 feet to the point of beginning.

RESERVING THEREFROM an easement for flood control, drainage purposes and sewer facilities over the southeasterly rectangular 16.00 feet thereof,

be and the same are hereby vacated.

BE IT FURTHER RESOLVED that the City Council does hereby determine that the public convenience and necessity require the reservation of an easement for flood control, drainage and sewer facilities and reserving the right to construct, reconstruct, maintain, operate, replace, remove, renew and enlarge flood control, drainage and sewer facilities, including access and the right to keep the property free from inflammable materials and wood growth that would interfere with the use of said flood control, drainage and sewer facilities.

IT IS FURTHER ORDERED that the City Clerk of said City of Riverside shall cause a certified copy of this order, attested by the City Clerk under the seal of said City to be recorded in the office of the County Recorder of Riverside County, California.


