RESOLUTION NO. 11732

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIVERSIDE, CALIFORNIA, CORRECTING A DESCRIPTION ERROR CONTAINED IN RESOLUTION NO. 9885 OF THE CITY OF RIVERSIDE WHEREIN A PORTION OF UNIVERSITY AVENUE, THEN CALLED EIGHTH STREET, WAS VACATED ON JANUARY 14, 1964.

WHEREAS Resolution No. 9885 vacated a certain portion of Eighth Street near Iowa Avenue on January 14, 1964; and

WHEREAS it has been discovered that there was an error in the description of said resolution; and

WHEREAS it is necessary to correct this description;

NOW, THEREFORE, BE IT RESOLVED AND ORDERED that the description contained in said Resolution No. 9885 is hereby amended and corrected to read as follows:

That portion of Lot 60 of the East Riverside Land Company's Subdivision of Section 19, Township 2 South, Range 4 West, San Bernardino Meridian, as shown by map on file in Book 6, Page 44 of Maps, records of San Bernardino County, California, more particularly described as follows:

Commencing at the south quarter corner of said Section 19; said corner also being the intersection of the centerline of Iowa Avenue with the centerline of University Avenue;

Thence North 0° 11' 02" East, along the centerline of said Iowa Avenue, a distance of 99.13 feet;

Thence west at right angles to the centerline of said Iowa Avenue, a distance of 55.00 feet to a point in the west line of said Iowa Avenue; said point also being the TRUE POINT OF BEGINNING;

Thence South 80° 17' 30" West, a distance of 199.65 feet to a point in the north line of University Avenue;

Thence South 89° 52' 00" East, along the north line of said University Avenue, a distance of 189.67 feet;

Thence North 45° 09' 34" East, a distance of 9.92 feet to the West line of said Iowa Avenue;

Thence North 0° 11' 02" East, along the west line of said Iowa Avenue, a distance of 27.12 feet to said TRUE POINT OF BEGINNING.

RESERVING all permanent easements and rights of way of every nature as provided in Section 8330 and 8331 of the Streets and Highways Code over, across, upon or under the portion of said street to be vacated.

IT IS FURTHER ORDERED that the City Clerk of said City of Riverside shall cause a certified copy of this order, attested by the City Clerk under the seal of said City to be recorded in
