RESOLUTION NO. 11876

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIVERSIDE, CALIFORNIA, MAKING ITS ORDER VACATING THE PROPOSED EASTERLY EXTENSION OF SAN VICENTE AVENUE.

WHEREAS on April 18, 1972, the City Council of the City of Riverside adopted Resolution No. 11862 declaring its intention to order the vacation of the proposed easterly extension of San Vicente Avenue and fixing the time and place of hearing all persons interested in the proposed vacation pursuant to the provisions of the Street Vacation Act of 1941, being Sections 8300 et seq. of Part 3, Division 9 of the Streets and Highways Code of the State of California; and

WHEREAS on the day fixed for the hearing the City Council heard and considered the evidence offered by persons interested and found, and hereby finds, from all of the evidence submitted that the proposed easterly extension of San Vicente Avenue is unnecessary for present or prospective public use;

NOW, THEREFORE, IT IS RESOLVED AND ORDERED by the City Council of the City of Riverside, California, that the said proposed easterly extension of San Vicente Avenue in the City of Riverside, County of Riverside, State of California, described as follows:

All that portion of Lots 3 and 4 in Block 6 of the Lands of Riverside Land and Irrigating Company as shown by map on file in Book 1 of Maps, at page 70 thereof, San Bernardino County Records, described as follows:

Commencing at the northeast corner of Lot 44 of Saint Paul Park Unit No. 2 as shown by Map on file in Book 28 of Maps, at Page 94 thereof, Records of Riverside County, California;

Thence North 89° 55' East, a distance of 60.00 feet to a point in the west line of that certain parcel of land conveyed to Clarence O. Willcut et ux, by deed recorded in Book 738 of Official Records of Riverside County, California, at Page 269 thereof;

Thence South 00° 05' East along said west line, a distance of 200.00 feet to a point thereon for the TRUE POINT OF BEGINNING;

Thence continuing South 00° 05' East along said west line a distance of 66.00 feet to a point thereon;

Thence, at a right angle, North 89° 55' East, a distance of 120.00 feet to a point in the east line of the parcel conveyed to Willcut as aforesaid;

Thence North 00° 05' West along said east line, a distance of 66.00 feet to a point thereon;


Thence, at a right angle, South 89° 55' West, a distance of 120.00 feet to the true point of beginning.

is unnecessary for present or prospective public use, and the same is hereby vacated.


