be changed to RIVERA STREET.

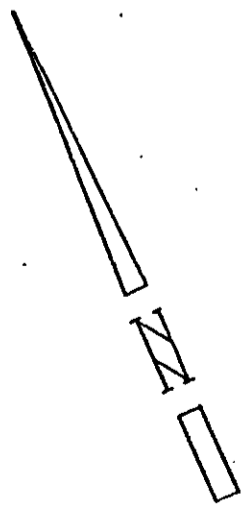
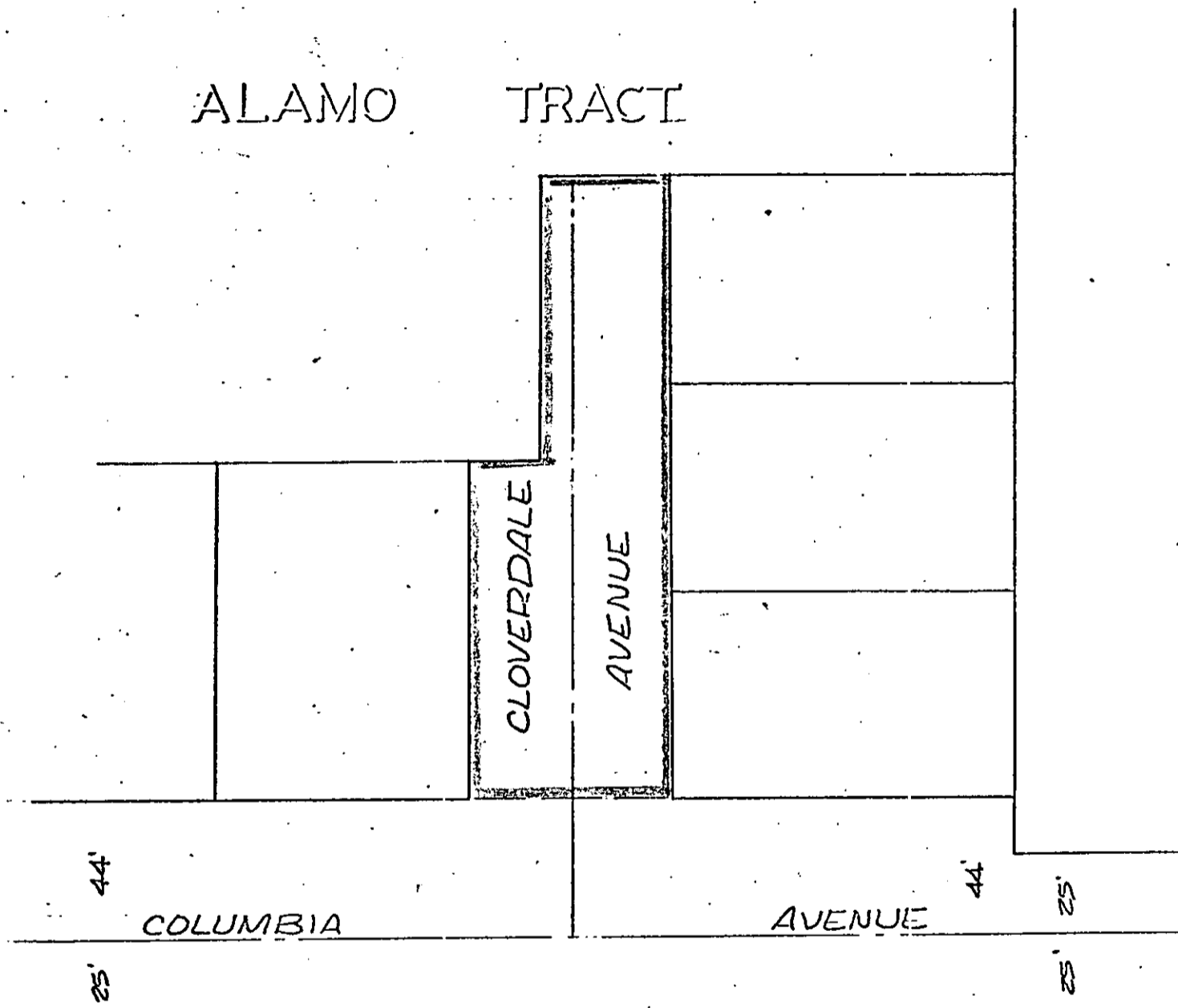
