BE IT RESOLVED by the City Council of the City of Riverside, California, pursuant to the recommendation of the Planning Commission of the City of Riverside that the name of a portion of Fischer Road described as follows:

All that portion of that certain street known as Fischer Road lying within the Northeast quarter of Section 4, Township 3 South, Range 4 West, San Bernardino Meridian,

be changed to BOX SPRINGS BOULEVARD.

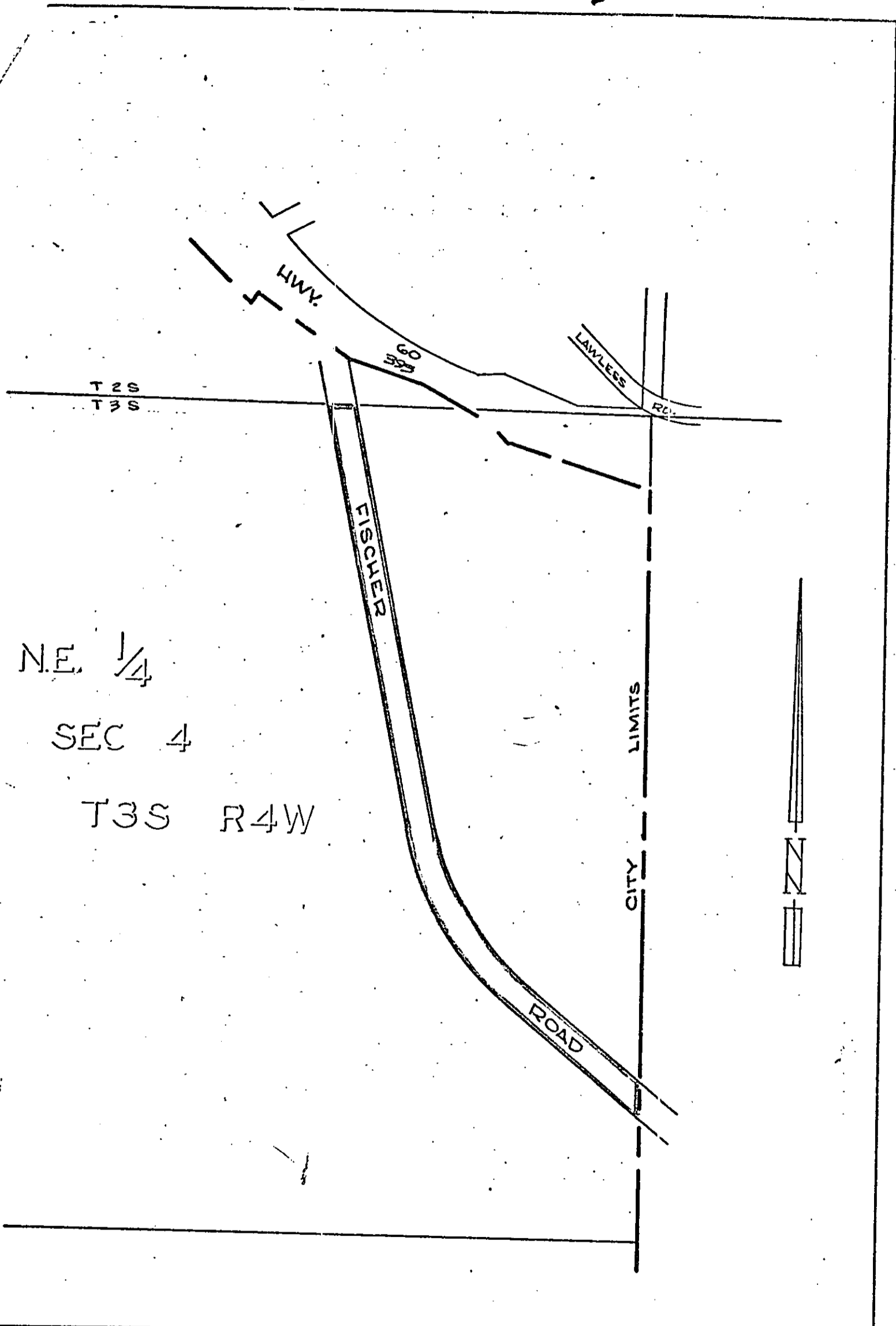
