A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIVERSIDE, CALIFORNIA, ACCEPTING A PORTION OF LENOX AVENUE BETWEEN WASHINGTON STREET AND ONOTA AVENUE AS A PUBLIC STREET.

BE IT RESOLVED by the City Council of the City of Riverside:

That the herein described property situated in the City of Riverside, County of Riverside, State of California, and described as follows:

That portion of Lot 6 in Division 'B' of WASHINGTON SQUARE, as shown by map on file in Book 4, Page 71 of Maps, records of Riverside County, California, more particularly described as follows:

BEGINNING at the east corner of said Lot 6;

Thence North 89° 57' 00" West, along the south line of said Lot 6, a distance of 750.00 feet, to the southwest corner of said Lot 6;

Thence North 30° 45' 00" West, along the southwest line of said Lot 6, a distance of 33.76 feet to a line that is parallel with and distant 29.00 feet north as measured at right angles to the south line of said Lot 6;

Thence South 89° 57' 00" East, along said parallel line, a distance of 717.69 feet;

Thence North 57° 00' 00" East, a distance of 24.86 feet to the northeast line of said Lot 6;

Thence South 34° 00' 00" East, along said northeast line, a distance of 51.36 feet to said POINT OF BEGINNING,

was accepted, and the dedication and acceptance is now acknowledged by this resolution, by the City of Riverside to public use for street purposes as a part of and to be known as a portion of Lenox Avenue. Said acceptance was based on use of said property for street purposes by the public and by the City of Riverside and construction and maintenance of said property by the City of Riverside for street purposes during the period of at least thirty-five years prior to the date of this resolution.


