A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIVERSIDE, CALIFORNIA, MAKING ITS ORDER VACATING A PUBLIC UTILITIES EASEMENT OVER PORTIONS OF LOTS 4 AND 5 OF TRACT NO. 2481.

The northwesterly 5.00 feet of Lot 5 and the southeasterly 5.00 feet of Lot 4 of Tract No. 2481, as shown by map on file in Book 48 of Maps, at pages 81 and 82 thereof, Records of Riverside County, California.

IT IS FURTHER ORDERED that the City Clerk of the City of Riverside shall cause a certified copy of this resolution and order, attested by the City Clerk under the seal of said City, to be recorded in the office of the County Recorder of Riverside County, California.
