

GRANT OF EASEMENT

COUNTY OF RIVERSIDE grants to CITY OF RIVERSIDE an easement for public street purposes (Harrison Street) in the real property in the City of Riverside, County of Riverside, State of California, described as follows:

That portion of Lot 39 in Block 11, as shown by Map of VILLAGE OF ARLINGTON on file in Book 1 of Maps, at page 62 thereof, records of San Bernardino County, California, described as follows:

BEGINNING at the most southerly corner of that certain parcel of land conveyed to the City of Riverside, a municipal corporation, by a deed recorded in Book 22 of Official Records, at page 93 thereof, records of Riverside County, California; said corner also being the intersection of the northwesterly line of Magnolia Avenue with a line which is parallel with and distant 27.00 feet southwest as measured at right angles to the northeast line of said Lot 39;

Thence South $56^{\circ} 21' 55''$ West, along the southeast line of said Lot 39, a distance of 32.38 feet to a point in a curve with a radius of 35.00 feet and concaving to the west; the radial line of said curve at said point bears South $67^{\circ} 40' 55''$ East;

Thence northeasterly, northerly and northwesterly, along said curve an arc length of 34.16 feet thru a central angle of $55^{\circ} 54' 44''$ to a line which is parallel with and distant 17.00 feet, measured at a right angle, from the southwest line of said parcel so conveyed to the City of Riverside;

Thence North $33^{\circ} 35' 39''$ West, along the last-mentioned parallel line, a distance of 111.04 feet;

Thence North $56^{\circ} 24' 21''$ East, 17.00 feet to said southwest line of said parcel conveyed to the City of Riverside;

Thence South $33^{\circ} 35' 39''$ East, along the last-mentioned southwest line, a distance of 140.00 feet to the point of beginning.

Area - 2,512.51 square feet.
