RESOLUTION NO. 12281

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIVERSIDE, CALIFORNIA, DEDICATING AND ACCEPTING CERTAIN CITY-OWNED LAND FOR PUBLIC STREET PURPOSES.

BE IT RESOLVED by the City Council of the City of Riverside:

That the herein described strip or parcel of land owned by the City of Riverside lying south of and adjacent to Linden Street be and is hereby dedicated by the City of Riverside and accepted for public use for street purposes.

Said parcel or strip of land is located in the City of Riverside, County of Riverside, State of California, and is described as follows:

The northerly 11.00 feet of Lot 54 of the Lands of the East Riverside Land Company in Section 19, Township 2 South, Range 4 West, San Bernardino Meridian as shown by map on file in Book 6, page 44 of Maps, Records of San Bernardino County, California; the southerly line of said northerly 11.00 feet being parallel with and distant southerly 11.00 feet as measured at right angles from the northerly line of said Lot 54.

EXCEPTING therefrom the easterly 198.00 feet of the westerly 231.00 feet of said Lot 54.

The City Clerk is authorized and directed to cause a certified copy of this resolution to be recorded by the County Recorder of Riverside County, California.
