

RESOLUTION NO. 12524

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIVERSIDE, CALIFORNIA, DEDICATING AND ACCEPTING CERTAIN CITY-OWNED LAND FOR PUBLIC STREET PURPOSES.

BE IT RESOLVED by the City Council of the City of Riverside: 8343

That the herein described strip or parcel of land owned by the City of Riverside, being a portion of the La Sierra library site and located at the northwesterly corner of La Sierra and Schuyler Avenues, be and is hereby dedicated by the City of Riverside and accepted for public use for street purposes.

Said parcel or strip of land is located in the City of Riverside, County of Riverside, State of California, and is described as follows:

That portion of Lot 1 in Block 57 of Tract No. 2 of LA SIERRA HEIGHTS as shown by map on file in Book 7 of Maps, at page 66 thereof, Records of Riverside County, California, described as follows:

Beginning at the most easterly corner of Parcel 2 of Record of Survey on file in Book 22 of Records of Surveys, at page 86 thereof, Records of Riverside County, California;

Thence South 56° 49' 48" West (recorded North 56° 49' 55" East), along the southeasterly line of said Parcel 2, a distance of 5.76 feet to a cusp of non-tangent curve, concave northwesterly and having a radius of 23.50 feet;

Thence northerly, along said curve, an arc length of 9.37 feet thru a central angle of 22° 50' 07" to a point in the northeasterly line of said Parcel 2;

Thence South 30° 51' 40" East (recorded North 30° 52' 15" West), along said northeasterly line, 7.08 feet to said Point of Beginning.

The City Clerk is authorized and directed to cause a certified copy of this resolution to be recorded by the County Recorder of Riverside County, California.
