RESOLUTION NO. 12525

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIVERSIDE, CALIFORNIA, DEDICATING AND ACCEPTING CERTAIN CITY-OWNED LAND FOR PUBLIC STREET PURPOSES.

BE IT RESOLVED by the City Council of the City of Riverside:

8344

That the herein described strip or parcel of land owned by the City of Riverside lying northerly of and adjacent to Tenth Street between Orange and Market Streets be and is hereby dedicated by the City of Riverside and accepted for public use for street purposes.

Said parcel or strip of land is located in the City of Riverside, County of Riverside, State of California, and is described as follows:

That portion of Lot 5 of MARTHA G. DAVIS SUBDIVISION as shown by map on file in Book 2 of Maps, at page 34 thereof, records of Riverside County, California, and that portion of Block 9, Ranges 6 and 7 and Main Street as shown by map on file in Book 7 of Maps, at page 17 thereof, records of San Bernardino County, California, described as follows:

BEGINNING at the most southerly corner of said Lot 5;

Thence northwesterly, along the northeasterly line of Tenth Street as shown on said map of the Town of Riverside, to the most westerly corner of Parcel 5 as conveyed to the City of Riverside, a municipal corporation, by Final Order of Condemnation, recorded June 30, 1972, as Instrument No. 87034, records of said Riverside County;

Thence northeasterly, along the northwesterly line of said Parcel 5, to a line which is parallel with and distant 38.00 feet northeasterly as measured at right angle to the centerline of said Tenth Street;

Thence southeasterly, along said parallel line, to the southeasterly line of said Lot 5;

Thence southwesterly, along said southeasterly line, to said POINT OF BEGINNING.

The City Clerk is authorized and directed to cause a certified copy of this resolution to be recorded by the County Recorder of Riverside County, California.
