FOR A VALUABLE CONSIDERATION, receipt of which is hereby acknowledged,
GERALDINE CAMARANO, also known as GERALDINE CUSHEN and JEROME A.

does hereby remise, release, and forever quitclaim to the CITY OF
RIVERSIDE the real property in the City of Riverside, County of Riverside,
State of California, described as follows:

PARCEL 1

That portion of Lots F and G and of Block 8 of TRACT NO.
4 of the RIVERVIEW ADDITION to the City of Riverside, as
shown by map on file in Book 7 of Maps, at page 6 thereof,
records of Riverside County, California, described as
follows:

Commencing at the intersection of the centerline of Gage
Street (formerly Norton Street) with the centerline of
Wilderness Avenue, (formerly Marion Street); said inter-
section also being a point in the west line of Lot 2 of
Rancho La Sierra, as shown on said Tract No. 4 of the
Riverview Addition;

Thence North 0° 04' 10" East, along said centerline of
Wilderness Avenue, 749.76 feet to its intersection with
the centerline of Roby Street (rejected) as shown on said
map;

Thence North 89° 57' 39" East, along said centerline of
Roby Street, 30.00 feet to its intersection with the
southerly prolongation of the easterly line of said
Wilderness Avenue;

Thence North 0° 06' 05" East, along said southwesterly
prolongation, 25.00 feet to the southwesterly corner of

Thence continuing North 0° 06' 05" East, along said
easterly line of Wilderness Avenue, 238.43 feet to a
point in a curve in the centerline of Backus Drive
(formerly Riverview Drive) as shown on said map; said
curve being concave northerly and having a radius of
80.00 feet; the radial line at said point bears South
10° 11' 58" East;

Thence westerly along said centerline an arc length of
30.18 feet thru a central angle of 21° 36' 55" to the
southerly prolongation of the westerly line of said Lot G;

Thence North 0° 06' 05" East, along said southerly prolonga-
tion and along said westerly line, 179.29 feet to an angle

Thence North 89° 58' 20" East, along said northerly line, 548.00 feet;

Thence South 0° 02' 23" East, a distance of 118.29 feet to a line which is parallel with and distant northeasterly 700.00 feet, as measured at right angles, from the northeasterly line of the Metropolitan Water District right of way (150 feet in width) as conveyed by deed recorded October 22, 1935, in Book 255 page 419 of Official Records of Riverside County, California;

Thence South 23° 21' 28" East, along said parallel line, 624.10 feet to a point in a curve in the easterly line of said Block 8; said curve being concave easterly and having a radius of 70.00 feet; the radial line at said point bears North 44° 05' 16" West;

Thence southerly along said curve an arc length of 61.99 feet thru a central angle of 50° 44' 29" to the northerly line of said Roby Street;

Thence South 89° 57' 39" West, along said northerly line, 747.93 feet to the TRUE POINT OF BEGINNING.

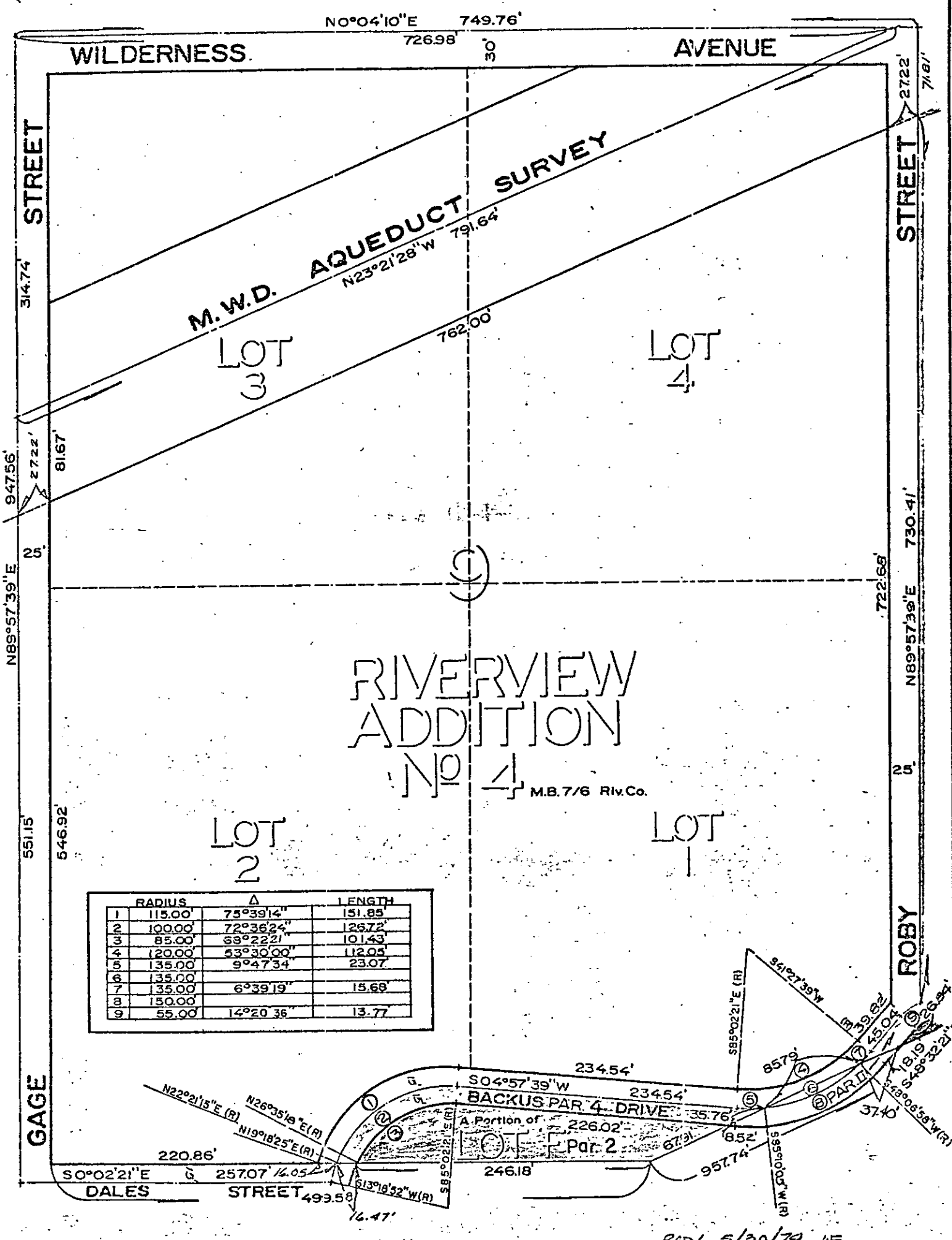
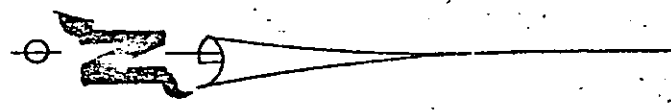

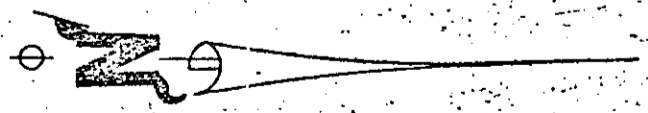
