A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIVERSIDE, CALIFORNIA, ACCEPTING THE DEDICATION OF A PORTION OF A STREET LYING WITHIN TRACT NO. 5 OF THE RIVERVIEW ADDITION TO THE CITY OF RIVERSIDE TO PUBLIC USE FOR STREET PURPOSES TO BE KNOWN AS A PORTION OF MOUNTAIN VIEW AVENUE.

BE IT RESOLVED by the City Council of the City of Riverside:

That the herein described parcel of land lying within Tract No. 5 of the Riverview Addition to the City of Riverside is hereby accepted by the City of Riverside to public use for street purposes to become and be known as a portion of MOUNTAIN VIEW AVENUE. Said parcel of land is located in the City of Riverside, County of Riverside, State of California, and is described as follows:

The East one-half of MOUNTAIN VIEW AVENUE, lying North of the west prolongation of the north line of Lot 6 in Block 29 of TRACT NO. 5 of THE RIVERVIEW ADDITION to the City of Riverside, as shown by map on file in Book 7 of Maps, at page 7 thereof, Records of Riverside County, California, and lying south of the southwesterly prolongation of the northwesterly line of Lot 9 in said Block 29.

The City Clerk is authorized and directed to cause a certified copy of this resolution to be recorded by the County Recorder of Riverside County, California.
