RESOLUTION NO. 12705

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIVERSIDE, CALIFORNIA, DEDICATING AND ACCEPTING CERTAIN CITY-OWNED LAND FOR PUBLIC ALLEY PURPOSES. 8559

BE IT RESOLVED by the City Council of the City of Riverside that the herein described strips or parcels of land owned by the City of Riverside and lying adjacent to the City Hall site and located generally between Ninth and Tenth Streets be and are hereby dedicated by the City of Riverside and accepted for public use for alley purposes.

Said parcels or strips of land are located in the City of Riverside, County of Riverside, State of California, and are described as follows:

Parcel 1

The Southeasterly 5.00 feet of Lots 1 thru 5 inclusive as shown by map recorded in Book 2 of Maps, at Page 34 thereof, Records of Riverside County, California; said map also known as Martha G. Davis Resubdivision.

EXCEPTING therefrom the Southwesterly 5.00 feet of the Southeasterly 5.00 feet of said Lot 5.

Parcel 2

A strip of land 2.00 feet in width over Block 9, Range 7 of THE TOWN OF RIVERSIDE, recorded in Book 7 of Maps, at page 17 thereof, records of San Bernardino County, California, described as follows:

Beginning at the southwesterly line of Ninth Street 172 feet Southeasterly from the northwesterly corner of said Block 9, Range 7;

Thence Southwesterly parallel with and distant 12 feet Southeasterly, as measured at right angle, from the centerline of a 20-foot-wide alley, 325 feet, more or less, to a line which is parallel with and distant 38 feet Northeasterly, as measured at right angle, from the centerline of Tenth Street; said alley conveyed to the City of Riverside by Grant Deed recorded November 16, 1901 in Book 133 of Deeds, at Page 68 thereof, records of Riverside County, California;

Thence Northwesterly along said line which is parallel with and distant 38 feet Northeasterly, as measured at right angle, from the centerline of Tenth Street, 2 feet to the southeasterly line of said alley;


Thence Northeasterly along said southeasterly line 325 feet, more or less, to said southwesterly line of Ninth Street;


Thence Southeasterly along said southwesterly line of Ninth Street 2 feet to the point of beginning.



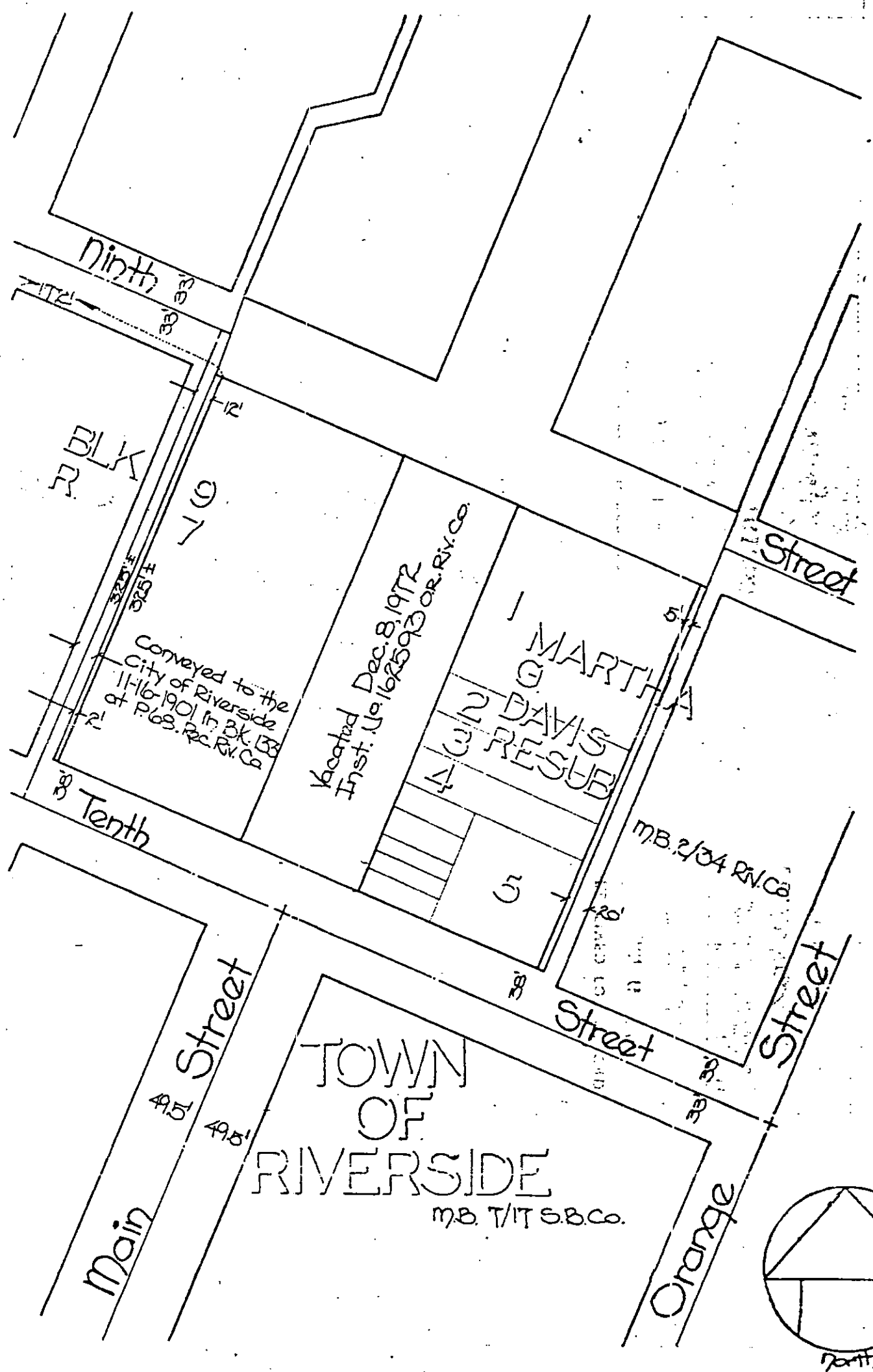
